AN ACT

1 APPROPRIATING ADDITIONAL MONEYS TO THE ATTORNEY GENERAL FOR FISCAL YEAR
2 2011; APPROPRIATING MONEYS TO THE ATTORNEY GENERAL FOR FISCAL YEAR
3 2012; LIMITING THE NUMBER OF FULL-TIME EQUIVALENT POSITIONS; EXEMPTING
4 APPROPRIATION OBJECT AND PROGRAM TRANSFER LIMITATIONS; AND DECLARING
5 AN EMERGENCY.

7 Be It Enacted by the Legislature of the State of Idaho:

8 SECTION 1. In addition to the appropriation made in Section 2, Chapter
9 227, Laws of 2010, and any other appropriation provided for by law, there is
10 hereby appropriated to the Attorney General \$33,100 from the Consumer Pro-
11 tection Fund to be expended for the period July 1, 2010, through June 30,
12 2011.

13 SECTION 2. There is hereby appropriated to the Attorney General, the
14 following amounts to be expended according to the designated programs and
15 expense classes, from the listed funds for the period July 1, 2011, through
16 June 30, 2012:

SECTION 3. FTP AUTHORIZATION. In accordance with Section 67-3519, Idaho Code, the Attorney General is authorized no more than two hundred seven and fifteen hundredths (207.15) full-time equivalent positions at any point during the period July 1, 2011, through June 30, 2012, unless specifically authorized by the Governor. The Joint Finance-Appropriations Committee will be notified promptly of any increased positions so authorized.

SECTION 4. EXEMPTIONS FROM OBJECT AND PROGRAM TRANSFER LIMITATIONS. For fiscal year 2012, the Attorney General is hereby exempted from the provisions of Section 67-3511(1), (2) and (3), Idaho Code, allowing unlimited transfers between object codes and between programs, for all moneys appropriated to it for the period July 1, 2011, through June 30, 2012. Legislative appropriations shall not be transferred from one fund to another fund unless expressly approved by the Legislature.

SECTION 5. An emergency existing therefor, which emergency is hereby declared to exist, Section 1 of this act shall be in full force and effect on and after passage and approval.
