AN ACT

1 RELATING TO SHEEP; AMENDING SECTION 25-126, IDAHO CODE, TO REVISE THE NAME  
2 OF THE STATE BOARD OF SHEEP COMMISSIONERS TO THE IDAHO SHEEP AND GOAT  
3 HEALTH BOARD; AMENDING SECTION 25-127, IDAHO CODE, TO REVISE THE NAME  
4 OF A BOARD, TO PROVIDE THAT BOARD MEMBERS SHALL SERVE AT THE PLEASURE OF  
5 THE GOVERNOR, TO REVISE TERMINOLOGY, TO REVISE THE NAME OF AN ACCOUNT,  
6 TO PROVIDE THAT THE IDAHO SHEEP AND GOAT HEALTH BOARD MAY REQUEST THE RE-  
7 MOVAL OF A BOARD MEMBER AND TO PROVIDE THAT UPON RECEIPT OF A REQUEST FOR  
8 REMOVAL OF A BOARD MEMBER, THE GOVERNOR MAY WITHDRAW THE BOARD MEMBER'S  
9 APPOINTMENT; AMENDING SECTION 25-128, IDAHO CODE, TO REVISE THE NAME OF  
10 A BOARD; AMENDING SECTION 25-129, IDAHO CODE, TO REVISE THE NAME OF AN  
11 ACCOUNT, TO REMOVE A REQUIREMENT FOR APPROVAL OF THE GOVERNOR RELATING  
12 TO THE BOARD'S APPOINTMENT OF A VETERINARIAN AND TO REVISE THE NAME OF  
13 A BOARD; AMENDING SECTION 25-130, IDAHO CODE, TO REVISE THE NAME OF AN  
14 ACCOUNT AND TO MAKE A TECHNICAL CORRECTION; AMENDING SECTION 25-131,  
15 IDAHO CODE, TO REVISE THE NAME OF AN ACCOUNT, TO REVISE TERMINOLOGY,  
16 TO REVISE ASSESSMENT PROVISIONS AND TO PROVIDE THAT THE BOARD MAY BY  
17 RULE ESTABLISH AN ASSESSMENT ON GOATS THAT WOULD ASSESS GOATS ON A PER  
18 HEAD BASIS AND AT A RATE THAT IS COMPARABLE TO THE ASSESSMENT ON WOOL;  
19 AMENDING SECTION 25-136, IDAHO CODE, TO REVISE THE NAME OF AN ACCOUNT;  
20 AMENDING SECTION 25-141B, IDAHO CODE, TO REVISE TERMINOLOGY; AMENDING  
21 SECTION 25-141C, IDAHO CODE, TO REVISE TERMINOLOGY AND TO MAKE A TECHNICAL  
22 CORRECTION; AMENDING SECTION 25-141D, IDAHO CODE, TO REVISE TERMINOLOGY,  
23 TO PROVIDE FOR THE RECEIPT OF IDAHO SHEEP AND GOAT HEALTH FUNDS  
24 INTO THE SHEEP AND GOAT DISEASE INDEMNITY FUND AND TO MAKE A TECHNICAL  
25 CORRECTION; AMENDING SECTIONS 25-143, 25-144, 25-145, 25-146, 25-148  
26 AND 25-150, IDAHO CODE, TO REVISE TERMINOLOGY; AMENDING SECTION 25-155,  
27 IDAHO CODE, TO REVISE TERMINOLOGY AND TO REVISE THE NAME OF A BOARD;  
28 AMENDING SECTION 25-156, IDAHO CODE, TO REMOVE PROVISIONS RELATING TO  
29 THE DEPOSIT OF CERTAIN MONEYS, TO REMOVE PROVISIONS RELATING TO THE  
30 WITHDRAWAL OF MONEYS, TO REMOVE AUDIT PROVISIONS, TO PROVIDE THAT THE  
31 BOARD, OR ENTITY THE BOARD HAS CONTRACTED WITH, SHALL FILE CERTAIN RE-  
32 PORTS AND TO REMOVE EXEMPTION PROVISIONS RELATED TO STANDARD TRAVEL AND  
33 PAY ALLOWANCES FOR SPECIFIED EXPENDITURES; REPEALING SECTION 25-157,  
34 IDAHO CODE, RELATING TO BONDS OF AGENTS AND EMPLOYEES; AMENDING SECTION  
35 25-158, IDAHO CODE, TO REVISE TERMINOLOGY; AMENDING SECTION 25-160,  
36 IDAHO CODE, TO PROVIDE FOR THE IDAHO SHEEP AND GOAT HEALTH BOARD AND  
37 TO REVISE TERMINOLOGY; AMENDING SECTION 25-201, IDAHO CODE, TO REVISE  
38 TERMINOLOGY; AMENDING SECTION 25-218, IDAHO CODE, TO REVISE THE NAME  
39 OF A BOARD; AMENDING SECTION 25-232, IDAHO CODE, TO REVISE THE NAME OF  
40 A BOARD, TO REVISE TERMINOLOGY AND TO MAKE A TECHNICAL CORRECTION; AND  
41 AMENDING SECTIONS 25-2612A AND 67-5303, IDAHO CODE, TO REVISE THE NAME  
42 OF A BOARD.

44 Be It Enacted by the Legislature of the State of Idaho:

1 SECTION 1. That Section 25-126, Idaho Code, be, and the same is hereby  
2 amended to read as follows:

3 25-126. CREATION OF BOARD. ~~A state board of sheep commissioners~~ The  
4 Idaho sheep and goat health board is hereby created within the department of  
5 agriculture, but its officers and employees shall not be subject to the ad-  
6 ministrative control of the director of the department of agriculture. The  
7 administrative officers and employees of the board shall be nonclassified  
8 employees. The board may contract with the director of the department of  
9 agriculture for administrative and/or veterinary services.

10 SECTION 2. That Section 25-127, Idaho Code, be, and the same is hereby  
11 amended to read as follows:

12 25-127. MEMBERS -- APPOINTMENT, QUALIFICATIONS, SALARY -- OATH. The  
13 ~~state board of sheep commissioners~~ Idaho sheep and goat health board, here-  
14 inafter called the board, shall consist of five (5) members, all of whom  
15 shall be experienced wool growers and no two (2) of whom shall be from the  
16 same county; said members shall be appointed by, and serve at the pleasure  
17 of, the governor. Members shall and hold their offices for the term for which  
18 they are appointed and thereafter until their successors are duly appointed  
19 and qualified.

20 As vacancies occur upon the board, the Idaho Wool Growers Association  
21 shall submit to the governor the names of two (2) persons qualified and suit-  
22 able for appointment for each such vacancy from whom the governor shall make  
23 his appointment to fill such vacancies. The first ~~commissioners board~~ shall  
24 be appointed for the following terms: two (2) ~~commissioners members~~ shall  
25 be appointed to hold office until the first Monday of January 1952; two (2)  
26 ~~commissioners members~~ shall be appointed to hold office until the first Mon-  
27 day of January 1954; one (1) ~~commissioner member~~ shall be appointed to hold  
28 office until the first Monday of January 1956; and at the expiration of said  
29 dates for the ~~commissioners members~~ first appointed and until the expiration  
30 of terms thereafter, ~~commissioners members~~ shall be appointed to fill such  
31 vacancies for a term of six (6) years; and in case of any vacancy occurring  
32 in the office of ~~commissioner~~ a board member at any time other ~~commissioners~~  
33 ~~members~~ shall be appointed, who in each instance shall hold office until the  
34 unexpired term of the ~~commissioner member~~ whom he is appointed to succeed.  
35 Each of said ~~commissioners members~~, before entering upon the duties of his  
36 office, shall take and subscribe to the oath of office required by section  
37 59-401, Idaho Code. The members of the board may be compensated as provided  
38 by section 59-509(d), Idaho Code. Said compensation may be paid from the  
39 ~~sheep commission~~ Idaho sheep and goat health account in the same manner as  
40 other expenses are paid. Each member of said board shall be a qualified elec-  
41 tor of the county from which he is chosen and must reside during his term of  
42 office within the state of Idaho. Said board must hold a meeting annually and  
43 at any other time if so requested by any member of the board. The Idaho sheep  
44 and goat health board may request the removal of a board member, with or with-  
45 out cause, by a majority vote. Upon receipt of the request, the governor may  
46 immediately withdraw the board member's appointment.

1 SECTION 3. That Section 25-128, Idaho Code, be, and the same is hereby  
2 amended to read as follows:

3 25-128. POWERS AND DUTIES OF ~~STATE BOARD OF SHEEP COMMISSIONERS~~ THE  
4 IDAHO SHEEP AND GOAT HEALTH BOARD. The board shall have the authority to  
5 perform all those duties and powers necessary for the prevention, control,  
6 and eradication of diseases which may include the supervision of sheep,  
7 handling of sheep, shipping, transporting or moving of sheep, regulation of  
8 sheep, the making of rules concerning sheep and all other matters pertaining  
9 to sheep either in the state of Idaho or which may be brought into or shipped  
10 from the state of Idaho. The board shall also be responsible for all matters  
11 relating to the prevention, control, and eradication of diseases pertaining  
12 to goats within the state of Idaho with the provisions of this chapter also  
13 applying to goats. The board may also designate a portion of the assessment,  
14 as provided in sections 25-130 and 25-131, Idaho Code, to help carry on the  
15 work for the prevention and control of damage caused by predatory animals and  
16 other vertebrate pests.

17 SECTION 4. That Section 25-129, Idaho Code, be, and the same is hereby  
18 amended to read as follows:

19 25-129. RULES -- EXECUTIVE SECRETARY, VETERINARIAN, INSPECTORS,  
20 SALARIES, EXPENSES AND OFFICE. (1) The board shall elect one (1) of its  
21 members chairman. The said board is empowered to make rules for governing  
22 itself and such rules as it may deem necessary for the enforcement of the  
23 provisions of this chapter and to enforce all such rules, and shall have ex-  
24 clusive control of all matters pertaining to the sheep industry. It shall be  
25 empowered to make and enforce rules for quarantining, or otherwise treating  
26 sheep which may be infected, affected or infested with ticks, lice or any  
27 other parasites detrimental or injurious to sheep, or any infectious or con-  
28 tagious disease of sheep and for the prevention, control and eradication of  
29 infectious or contagious diseases, ticks, lice or other parasites detrimen-  
30 tal to sheep. All such rules adopted by said board shall have the same force  
31 and effect as law and any person, association, firm or corporation violating  
32 such rules shall be deemed guilty of a misdemeanor.

33 (2) The board is empowered to select an executive secretary who may or  
34 may not be a member of the board, and such executive secretary shall have the  
35 authority and power to sign any and all lawful claims or vouchers to be made,  
36 filed or drawn by or on behalf of the board against the ~~sheep commission~~ Idaho  
37 sheep and goat health account, and for such purposes he shall be regarded  
38 as the administrative head of the agency and he shall perform such other and  
39 further duties as the board shall direct.

40 (3) The board is empowered to appoint, ~~with the approval of the gov-~~  
41 ~~ernor,~~ a veterinarian in charge, who must be duly licensed in the state of  
42 Idaho and who is a graduate of a recognized and accredited school of veteri-  
43 nary medicine, whose duties and powers shall be defined and prescribed by  
44 said board; which said officer shall be bonded to the state of Idaho in the  
45 time, form and manner prescribed by chapter 8, title 59, Idaho Code. The vet-  
46 erinarian in charge shall receive such compensation as may be allowed by said  
47 board and actual and necessary expenses incurred in the performance of his  
48 duties. The veterinarian in charge shall be at all times subject to the au-

1     thority of the board and shall have the same powers hereinafter provided for  
 2     all other inspectors appointed by the board under this chapter. The veteri-  
 3     narian in charge shall have authority and power to sign all lawful claims or  
 4     vouchers filed or drawn on behalf of the board against the ~~sheep commission~~  
 5     Idaho sheep and goat health account.

6     (4) The board is hereby empowered to appoint all other inspectors, vet-  
 7     erinarians and such other employees and assistants as may be necessary to  
 8     carry out the duties and powers herein conferred and fix the compensation  
 9     of all such appointees. All salaries and expenses of every kind incurred in  
 10    carrying out the provisions of this chapter shall be paid from the ~~sheep com-~~  
 11   ~~mission~~ Idaho sheep and goat health account.

12    (5) Inspectors and veterinarians appointed by the ~~board of sheep com-~~  
 13   ~~missioners~~ Idaho sheep and goat health board shall have the power and duty to  
 14    assist law enforcement entities in the enforcement of all laws of the state  
 15    pertaining to the identification, inspection and transportation of sheep  
 16    and other livestock, and shall have general authority to assist law enforce-  
 17    ment entities in the enforcement of theft laws of the state with respect to  
 18    sheep and other livestock.

19    SECTION 5. That Section 25-130, Idaho Code, be, and the same is hereby  
 20    amended to read as follows:

21    25-130.   FIXING ASSESSMENT RATE -- PAYMENT OF CLAIMS -- REPORT -- IN-  
 22    SPECTION, QUARANTINE AND TREATMENT OF SHEEP -- DISTRICTS. The board shall  
 23    meet and fix the rate of special assessment to be levied as provided for in  
 24    this chapter. Any change in the rate of the special assessment shall be made  
 25    to be effective at the start of a calendar year. The board shall audit all  
 26    bills of salaries and expenses incurred in the enforcement of this chapter  
 27    that may be payable from the ~~sheep commission~~ Idaho sheep and goat health ac-  
 28    count which shall be audited, allowed and paid as other claims against the  
 29    state. The board shall have power to order an inspection or quarantine of any  
 30    sheep in the state of Idaho, whether diseased or exposed to disease, to com-  
 31    pel dipping or other treatment of sheep, whether diseased or exposed to dis-  
 32    ease, at such times and as often as it deems necessary to ~~insure~~ ensure the  
 33    suppression or eradication of any infectious or contagious disease of sheep  
 34    and divide the state into such districts as may be necessary for the enforce-  
 35    ment of this chapter.

36    SECTION 6. That Section 25-131, Idaho Code, be, and the same is hereby  
 37    amended to read as follows:

38    25-131.   ~~SHEEP COMMISSION~~ IDAHO SHEEP AND GOAT HEALTH ACCOUNT -- AS-  
 39    SESSMENT -- FIRST PURCHASER TO MAKE REPORT -- PENALTY FOR FAILURE TO MAKE  
 40    REPORT -- APPROPRIATION. (1) In order for the board ~~of sheep commissioners~~  
 41    to carry out the provisions of this chapter, the board shall assess, levy  
 42    and collect an assessment established by the board, not to exceed ~~six~~ twelve  
 43    cents (~~6~~12¢) per pound on all wool, in the grease basis, sold through commer-  
 44    cial channels. In the event that a sheep, which produces wool subject to this  
 45    assessment, shall be located outside the state of Idaho during a part of the  
 46    assessment year, the amount of the assessment shall be reduced on a pro rata  
 47    basis. Such assessment shall be levied and assessed to the producer at the

1 time of the first sale of wool and shall be deducted by the first purchaser  
2 from the price paid to the producer at the time of such first sale. The as-  
3 sessment provided in this section shall not be levied or collected on any ca-  
4 sual sale. In addition to the assessment provisions of this section related  
5 to wool, the board may by rule establish an assessment on goats that would as-  
6 sess goats on a per head basis and at a rate that is comparable to the assess-  
7 ment on wool.

8 (2) The assessment provided by this section shall constitute a lien  
9 prior to all other liens and encumbrances upon such wool except liens which  
10 are declared prior by operation of a statute of this state.

11 (3) If the first purchaser lives or has his principal office in another  
12 state, the producer shall make the reports and pay the assessments to the  
13 board as required under this section unless the first purchaser agrees in  
14 writing to make such reports and pay such assessments.

15 (4) The first purchaser shall specify the amounts of assessments with-  
16 held in any written statements made to the producer.

17 (5) The first purchaser shall make reports to the board on forms pre-  
18 scribed by the board, and no first purchaser shall fail to make such reports  
19 or falsify any such reports. The assessment deducted and withheld by a first  
20 purchaser, as required in subsection (1) of this section, shall be paid to  
21 the board on a quarterly calendar year basis, and shall be due and payable  
22 within thirty (30) days after the end of the quarter. All moneys collected  
23 by the board under the provisions of this chapter shall be paid to the state  
24 treasurer. All moneys received from the assessment pursuant to this section  
25 shall be deposited in the state treasury by the state treasurer to the credit  
26 of a special account in the state operating fund hereby created to be known as  
27 the "~~sheep commission~~ Idaho sheep and goat health account."

28 (6) A first purchaser who delays transmittal of reports and payments of  
29 assessments beyond the time stated in subsection (5) of this section shall  
30 pay five percent (5%) of the amount due for the first month of delay and one  
31 percent (1%) of the amount due for each month of delay thereafter. Such mon-  
32 eys shall be deposited in the ~~sheep commission~~ Idaho sheep and goat health  
33 account.

34 (7) In addition thereto, the said account shall consist of any appro-  
35 priations made by the legislature for the use of and expenditure by said  
36 board. All fees of every kind collected under the provisions of this chap-  
37 ter, or under any rules and regulations made pursuant to the provisions of  
38 this chapter, shall be deposited in the state treasury in the manner herein-  
39 above described. The moneys in said special account are hereby appropriated  
40 for the use and expenditure of said board carrying out the provisions of this  
41 chapter and the rules and regulations made herein and said account is hereby  
42 declared to be a continuing account.

43 (8) All moneys appropriated to the board for the purposes of sheep dis-  
44 ease prevention, abatement, suppression, control or eradication shall be  
45 expended by the board only for those purposes, in accordance with the duties  
46 specified in section 25-128(1), Idaho Code.

47 (9) All moneys received by the ~~state board of sheep commissioners~~  
48 that portion of the special assessment which is made to carry on the work  
49 for prevention and control of damage caused by predatory animals and other  
50 vertebrate pests shall be expended by the ~~sheep commission~~ board in the

1     respective districts comprising the counties where the assessment was col-  
 2     lected less the actual and necessary administrative costs for carrying out  
 3     the provisions of this chapter. All moneys received by such account for work  
 4     for prevention and control of damage caused by predatory animals and other  
 5     vertebrate pests except as herein otherwise provided shall be expended by  
 6     the ~~sheep commission board~~ within the district or districts specified by the  
 7     party or agency providing such funds and any trust fund must be held invio-  
 8     late for the purposes of the trust.

9             SECTION 7. That Section 25-136, Idaho Code, be, and the same is hereby  
 10     amended to read as follows:

11             25-136.    APPROPRIATION FOR SALARY AND EXPENSES. The salaries, expenses  
 12     and maintenance of the said board and all other salaries and expenses not  
 13     otherwise provided for, not heretofore provided for in this act, shall be  
 14     paid out of the ~~sheep commission fund~~ Idaho sheep and goat health account.  
 15     The legislature may each year set aside from the total appropriation which  
 16     it shall make for the care, handling, inspection and protection and erad-  
 17     ication of disease of livestock in the state, that proportion of the total  
 18     amount which the value of the sheep and goats in the state of Idaho bears to  
 19     the value of other livestock in the state as determined by the director of the  
 20     department of agriculture.

21             SECTION 8. That Section 25-141B, Idaho Code, be, and the same is hereby  
 22     amended to read as follows:

23             25-141B.   EXTENT OF ERADICATION AREA -- SUPERVISION AND QUARANTINE OF  
 24     PREMISES. The ~~state board of sheep commissioners~~ is hereby authorized to  
 25     quarantine any portion of this state when the fact is determined that sheep  
 26     or goats are affected with scrapie or any other contagious, infectious or  
 27     communicable disease. The area designated for the control of scrapie may  
 28     consist of the entire state, a portion of the state, entire county, or part  
 29     of the county, if it is less than the entire county; the boundary of the area  
 30     shall be clearly defined in the order for the establishment of the area.

31             SECTION 9. That Section 25-141C, Idaho Code, be, and the same is hereby  
 32     amended to read as follows:

33             25-141C.   SHEEP -- GOATS -- SCRAPIE -- OR OTHER DISEASES -- HERD DEPOP-  
 34     ULATION. In order to prevent the introduction or dissemination of scrapie  
 35     or other contagious, infectious or communicable diseases into or among the  
 36     sheep or goat population of Idaho, the board is granted authority to identify  
 37     diseases of concern and to condemn infected herds and to require the destruc-  
 38     tion or other disposition as approved by the board of such herd or herds. The  
 39     board ~~of sheep commissioners~~ is authorized to reimburse the owner by cash  
 40     payment for any affected or exposed sheep or goats which have been condemned,  
 41     appraised and slaughtered or destroyed or otherwise disposed of by direction  
 42     of the board ~~of sheep commissioners~~ and for property destroyed and for la-  
 43     bor employed in digging trenches and for cleaning and disinfecting premises  
 44     where such infected or exposed sheep and goats have been kept; provided, that  
 45     the board shall only pay the difference between the appraised price less fed-

1 eral indemnity and salvage value for any sheep or goats condemned and slaugh-  
2 tered or destroyed under this section and the actual costs for burials or  
3 disposal of animal carcasses and for cleaning and disinfecting of premises  
4 where infected or exposed sheep or goats have been kept. In the event federal  
5 indemnity is unavailable in regard to the value of the sheep or goats, the  
6 board shall only pay the difference between the appraised price and salvage  
7 value. Appraisals shall be performed by a team comprised of an animal health  
8 representative, the owner and a person with experience in sheep or goat mar-  
9 keting. A maximum per head value may ~~by~~ be established by rules of the board.  
10 The board or its designee may grant a hearing to any person, under such rules  
11 as the board may prescribe which are in compliance with chapter 52, title 67,  
12 Idaho Code, when the appraisal price is in dispute. An appeal may be taken  
13 from the decision of the board or its designee under the provisions of chap-  
14 ter 52, title 67, Idaho Code.

15 SECTION 10. That Section 25-141D, Idaho Code, be, and the same is hereby  
16 amended to read as follows:

17 25-141D. CREATION OF SHEEP AND GOAT DISEASE INDEMNITY FUND. There is  
18 hereby created within the department of agriculture a ~~state board of sheep~~  
19 ~~commissioners~~ account to be known as the sheep and goat disease indemnity  
20 fund. ~~Funds~~ Funds may be received into this account from any source including,  
21 but not limited to, donations, gifts, grants, federal funds, ~~sheep commis-~~  
22 ~~sion~~ Idaho sheep and goat health funds, or appropriations from general or  
23 dedicated accounts. Moneys received into this account shall be deposited  
24 with the state treasurer to the credit of the sheep and goat disease indem-  
25 nity fund. Moneys deposited into this account may only be used to indemnify  
26 owners whose animals or herds have been condemned or destroyed or otherwise  
27 disposed of by direction of the board, and for property destroyed, for labor  
28 employed in digging trenches, and for cleaning and disinfecting of premises  
29 where infected or exposed sheep and goats have been kept.

30 SECTION 11. That Section 25-143, Idaho Code, be, and the same is hereby  
31 amended to read as follows:

32 25-143. TRANSPORTATION OF SHEEP FROM QUARANTINED AREA. It shall be  
33 unlawful for any transportation company or operator of any motor truck to  
34 receive for transportation or transport from the quarantined area of this  
35 state into or through an unquarantined area of this state or receive for  
36 transportation or transport within the quarantined area of this state any  
37 sheep, or as a connecting carrier knowingly receive without the quarantined  
38 area, sheep from the quarantined area, and transport the same within the  
39 state, except as hereinafter provided; nor shall any person, company or  
40 corporation deliver for such transportation to any transportation company,  
41 or operator of any motor truck, any sheep from the quarantined area, except  
42 as hereinafter provided; nor shall any person, company or corporation drive  
43 on foot or cause to be driven on foot or transport in private conveyances  
44 or otherwise move within the quarantined area, any sheep except as here-  
45 inafter provided; and the ~~state board of sheep commissioners~~ shall make and  
46 promulgate rules which shall permit and govern the inspection, treatment,  
47 certification, handling and method and manner of delivery and shipment or

1 other movement of sheep from a quarantined area of this state, or the ship-  
2 ment or other movement of sheep within a quarantined area of this state.

3 SECTION 12. That Section 25-144, Idaho Code, be, and the same is hereby  
4 amended to read as follows:

5 25-144. MOVEMENT OF SHEEP FROM QUARANTINED INTO UNQUARANTINED AREA  
6 PROHIBITED. It shall be unlawful to move sheep from a quarantined area of the  
7 state in any manner whatsoever into an unquarantined area of this state or  
8 for connecting carriers to receive sheep of the quarantined area at a point  
9 outside of the quarantined area and transport the same within the state, ex-  
10 cept in accordance with the rules and regulations of the ~~state board of sheep~~

17 ~~state board of sheep commissioners~~ or any inspector or agent of the bureau  
18 of animal industry of the United States department of agriculture shall have  
19 authority to quarantine, where found, or in any convenient place nearby, any  
20 animals affected or infected with or exposed to the contagion or infection  
21 of any contagious, infectious or communicable disease. The establishment of  
22 any such quarantine shall be immediately reported to the board and said board  
23 is authorized and empowered to prescribe such rules and regulations as may be

26 of such quarantine shall be given to the owner or custodian of the quaran-

31 25-146. INSPECTION AND TREATMENT OF DISEASED SHEEP. The representa-  
32 tive of the ~~state board of sheep commissioners~~ or any inspector or agent of  
33 the United States bureau of animal industry shall have authority to enter  
34 upon any grounds or premises where sheep are kept and to inspect, diagnose  
35 and treat sheep found thereon. They shall be authorized and empowered to re-  
36 quire owners of sheep to apply such remedies, dips and other curative, pro-  
37 tective or preventive agents as may by the board be deemed necessary in order  
38 to prevent the introduction or dissemination of disease among the sheep of  
39 this state or to effect a cure of affected or infected sheep and in the event  
40 that any owner or custodian of such sheep shall refuse to comply with the

43 or by the rules of said board, then the board shall be empowered to treat or  
44 dip such sheep and the cost thereof, together with all incidental expenses

 2 representatives as herein provided, shall be borne by the owner of the sheep  
 3 so treated or dipped and shall be, until paid, a lien against such sheep.

6 (d) Except as otherwise provided by law, not more than one (1) declared  
7 position for each board or commission and/or head of a participating depart-  
8 ment in addition to those declared to be nonclassified by other provisions of

10 (e) Part-time professional consultants who are paid on a fee basis for  
11 any form of legal, medical or other professional service, and who are not en-  
12 gaged in the performance of administrative duties for the state.

13 (f) Judges, temporary referees, receivers and jurors.

14 (g) All employees of the Idaho supreme court, Idaho court of appeals and  
15 district courts.

16 (h) All employees of the Idaho state bar.

17 (i) Assistant attorneys general attached to the office of the attorney  
18 general.

19 (j) Officers, members of the teaching staffs of state educational in-  
20 stitutions, the professional staff of the Idaho department of education  
21 administered by the board of regents and the board of education, and the  
22 professional staffs of the Idaho division of professional-technical edu-  
23 cation and vocational rehabilitation administered by the state board for  
24 professional-technical education. "Teaching staff" includes teachers,  
25 coaches, resident directors, librarians and those principally engaged in  
26 academic research. The word "officer" means presidents, vice presidents,  
27 deans, directors, or employees in positions designated by the state board  
28 who receive an annual salary of not less than step "A" of the pay grade equiv-  
29 alent to three hundred fifty-five (355) Hay points in the state compensation  
30 schedule. A nonclassified employee who is designated as an "officer" on July  
31 5, 1991, but does not meet the requirements of this subsection, may make a

41 shall be termed "project exempt" and the tenure of their employment shall  
42 be limited to the length of the project grant, or twenty-four (24) months,  
43 or four thousand one hundred sixty (4,160) hours of credited state service,  
44 whichever is of the shortest duration. No person hired on a project-exempt  
45 appointment shall be employed in any position allocated to the classified

7 provided in chapter 36, title 22, Idaho Code; the Idaho cherry commission,

21 correction. Deputy administrators are defined as only the deputy adminis-  
22 trators working directly for the nonclassified division administrators un-  
23 der the director of the department of correction.

24 (s) All public information positions with the exception of secretarial  
25 positions, in any department.

26 (t) Any division administrator.

27 (u) Any regional administrator or division administrator in the de-  
28 partment of environmental quality.

29 (v) All employees of the division of financial management.

30 (w) All employees of the Idaho food quality assurance institute.

31 (x) The state appellate public defender, deputy state appellate public  
32 defenders and all other employees of the office of the state appellate public  
33 defender.

34 (y) All quality assurance specialists or medical investigators of the  
35 Idaho board of medicine.

36 (z) All pest survey and detection employees and their supervisors hired  
37 specifically to carry out activities under the Idaho plant pest act, chapter  
38 20, title 22, Idaho Code, including but not limited to pest survey, detec-  
39 tion and eradication, except those positions involved in the management of  
40 the program.
