

## STATEMENT OF PURPOSE

### RS21531

This is the appropriation bill for two of the divisions in the Department of Health and Welfare. It includes the Division of Medical Assistance Services and Licensing and Certification Divisions. It includes twelve line items which total an increase of \$38,705,900 from the General Fund, a reduction of \$500,000 in dedicated funds, and an increase of \$32,197,600 in federal funds for an overall increase of \$70,403,500. It appropriates \$1,916,400,800 and 268 FTP for fiscal year 2013.
