



He received the Clarence Darrow Award from the American Civil Liberties Union of Idaho for his defense of Sami Al-Hussayen. Mr. Nevin is a founder and past President of the Idaho Association of Criminal Defense Lawyers, and is the namesake of its Nevin Professionalism Award. which the organization awards annually to a criminal defense lawyer who has advanced the ideals of the profession. Mr. Nevin has twice received the organization's President's Award for outstanding service to criminal justice.






