SENATE AMENDMENT TO H.B. NO. 130

AMENDMENT TO SECTION 1

1
2 On page 1 of the printed bill, in line 34, delete ", or" and insert: "~~or~~ and"; and in line 35, following "qualified." insert: "If no director is
3 elected and qualified at the end of an incumbent director's three (3) year
4 term, an election shall be held at the next regular election of the irri-
5 gation district for the incumbent director's successor to hold office for
6 the remainder of the unexpired term. This election requirement shall ap-
7 ply retroactively where an incumbent director remains in office on the date
8 of the effective date of this act because the incumbent's successor was not
9 elected and qualified in the 2012 election.".

AMENDMENT TO SECTION 2

12 On page 2, in line 43, following "begin," insert: "at the meeting of the
13 irrigation district's board of directors as provided in section 43-201(2),
14 Idaho Code,"; in line 44, following "shall" insert: ": (1)"; in line 46,
15 following "Code" insert: "; (2) be presented a certificate of election; (3)
16 execute a bond if one (1) is hereinafter required; and (4) assume the duties
17 of the office of director. The incumbent director's term of office shall be
18 terminated upon the next director's assumption of office as provided in this
19 section".

32 VIDE FOR CERTIFICATES OF ELECTION, TO PROVIDE FOR BONDS, TO PROVIDE FOR AS-
33 SUMPTION OF DUTIES OF THE DIRECTOR AND TO PROVIDE FOR TERMINATION OF AN IN-
34 CUMBENT'S TERM OF OFFICE"; in line 14, delete "AND" and insert: ",,"; and in
35 line 15, following "RESULT" insert: "AND TO REMOVE PROVISIONS RELATING TO
36 CERTAIN DUTIES OF THE SECRETARY".
