SENATE BILL NO. 1108

AN ACT

1 RELATING TO INITIATIVE AND REFERENDUM ELECTIONS; AMENDING SECTION 34-1801A,
2 IDAHO CODE, TO REVISE PROVISIONS RELATING TO THE FORM OF CERTAIN PE-
3 TITIONS; AMENDING SECTION 34-1804, IDAHO CODE, TO REVISE PROVISIONS
4 RELATING TO CERTAIN SIGNATURE SHEETS; AMENDING SECTION 34-1805, IDAHO
5 CODE, TO REVISE PROVISIONS RELATING TO THE NUMBER OF SIGNATURES RE-
6 QUIRED ON CERTAIN PETITIONS; AND AMENDING SECTION 34-1807, IDAHO CODE,
7 TO REVISE PROVISIONS RELATING TO CERTAIN PETITIONS AND SIGNATURE SHEETS
8 AND TO MAKE A TECHNICAL CORRECTION.

10 Be It Enacted by the Legislature of the State of Idaho:

11 SECTION 1. That Section 34-1801A, Idaho Code, be, and the same is hereby
12 amended to read as follows:

13 34-1801A. PETITION. The following shall be substantially the form of
14 petition for any law proposed by the initiative:

15 WARNING

16 It is a felony for anyone to sign any initiative or referendum petition with
17 any name other than his own, or to knowingly sign his name more than once for
18 the measure, or to sign such petition when he is not a qualified elector.

19 INITIATIVE PETITION

20 To the Honorable, Secretary of State of the State of Idaho:

21 "We, the undersigned citizens and qualified electors of the State of Idaho,
22 respectfully demand that the following proposed law, to-wit: (setting out
23 full text of measure proposed) shall be submitted to the qualified electors
24 of the State of Idaho, for their approval or rejection at the regular general
25 election, to be held on the day of, A.D.,, and each for him-
26 self says: I have personally signed this petition; I am a qualified elector
27 of the State of Idaho; my residence and ~~post office~~ legislative district are
28 correctly written after my name.

33 (Here follow twenty numbered lines for signatures.)

34 The petition for referendum on any act passed by the state legislature of the
35 state of Idaho shall be in substantially the same form with appropriate title
36 and changes, setting out in full the text of the act of the legislature to be
37 referred to the people for their approval or rejection.

1 SECTION 2. That Section 34-1804, Idaho Code, be, and the same is hereby
2 amended to read as follows:

3 34-1804. PRINTING OF PETITION AND SIGNATURE SHEETS. Before or at the
4 time of beginning to circulate any petition for the referendum to the people
5 on any act passed by the state legislature of the state of Idaho, or for any
6 law proposed by the initiative, the person or persons or organization or or-
7 ganizations under whose authority the measure is to be referred or initiated
8 shall send or deliver to the secretary of state a copy of such petition duly
9 signed by at least twenty (20) qualified electors of the state which shall
10 be filed by said officer in his office, and who shall immediately transmit
11 a copy of the petition to the attorney general for the issuance of the cer-
12 tificate of review as provided in section 34-1809, Idaho Code. All petitions
13 for the initiative and for the referendum and sheets for signatures shall be
14 printed on a good quality of bond or ledger paper in the form and manner as ap-
15 proved by the secretary of state. To every sheet of petitioners' signatures
16 shall be attached a full and correct copy of the measure so proposed by ini-
17 tiative petition; but such petition may be filed by the secretary of state
18 in numbered sections for convenience in handling. Every sheet of petition-
19 ers' signatures upon referendum petitions shall be attached to a full and
20 correct copy of the measure on which the referendum is demanded, and may be
21 filed in numbered sections in like manner as initiative petitions. Not more
22 than twenty (20) signatures on one (1) sheet shall be counted. Each signa-
23 ture sheet shall contain signatures of qualified electors from only one (1)
24 county and legislative district.

25 SECTION 3. That Section 34-1805, Idaho Code, be, and the same is hereby
26 amended to read as follows:

27 34-1805. SPONSORS TO PRINT PETITION -- NUMBER OF SIGNERS REQUIRED. Af-
28 ter the form of the initiative or referendum petition has been approved by
29 the secretary of state as in sections 34-1801A through 34-1822, Idaho Code,
30 provided, the same shall be printed by the person or persons or organization
31 or organizations under whose authority the measure is to be referred or ini-
32 tiated and circulated in the several counties of the state for the signatures
33 of legal voters. Before such petitions shall be entitled to final filing and
34 consideration by the secretary of state there shall be affixed thereto the
35 signatures of legal voters equal in number to not less than six percent (6%)
36 of the qualified electors at the time of the last general election in each of
37 at least eighteen (18) legislative districts; provided however, the total
38 number of signatures shall be equal to or greater than six percent (6%) of the
39 qualified electors of the state at the time of the last general election.

40 SECTION 4. That Section 34-1807, Idaho Code, be, and the same is hereby
41 amended to read as follows:

42 34-1807. CIRCULATION OF PETITIONS -- VERIFICATION OF PETITION AND
43 SIGNATURE SHEETS -- COMPARISON OF SIGNATURES WITH REGISTRATION OATHS AND
44 RECORDS -- CERTAIN PETITIONS AND SIGNATURES VOID. Any person who circulates
45 any petition for an initiative or referendum shall be a resident of the state
46 of Idaho and at least eighteen (18) years of age. Each and every sheet of

1 every such petition containing signatures shall be verified on the face
2 thereof in substantially the following form, by the person who circulated
3 said sheet of said petition, by his or her affidavit thereon, and as a part
4 thereof:

8 I,, being first duly sworn, say: That I am a resident of the State
9 of Idaho and at least eighteen (18) years of age: that every person who
10 signed this sheet of the foregoing petition signed his or her name thereto
11 in my presence: I believe that each has stated his or her name, ~~post-office~~
12 ~~address~~ legislative district and residence correctly, that each signer is a
13 qualified elector of the State of Idaho, and a resident of legislative dis-
14 trict number in the county of

20 In addition to said affidavit the county clerk shall carefully examine
21 said petitions and shall attach to the signature sheets a certificate to the
22 secretary of state substantially as follows:

26 To the honorable, Secretary of State for the State of Idaho: I,

33 The county clerk shall deliver the petition or any part thereof to
34 the person from whom he received it with his certificate attached thereto
35 as above provided. The forms herein given are not mandatory and if sub-
36 stantially followed in any petition, it shall be sufficient, disregarding
37 clerical and merely technical error.

38 Any petition upon which signatures are obtained by a person not a resi-
39 dent of the state of Idaho and at least eighteen (18) years of age, shall be
40 void. The definition of resident in section 34-107, Idaho Code, shall apply
41 to the circulators of initiative and referendum petitions. In addition to ~~to~~
42 being a resident, a petition circulator shall be at least eighteen (18) years
43 of age.
