AN ACT

1 APPROPRIATING ADDITIONAL MONEYS TO THE DEPARTMENT OF SELF-GOVERNING AGEN-  
2 CIES FOR THE MEDICAL BOARDS FOR FISCAL YEAR 2014; REDUCING THE APPRO-  
3 PRIATION TO THE DEPARTMENT OF SELF-GOVERNING AGENCIES FOR THE MEDICAL  
4 BOARDS FOR FISCAL YEAR 2014; AND DECLARING AN EMERGENCY.

6 Be It Enacted by the Legislature of the State of Idaho:

7 SECTION 1. In addition to the appropriation made in Section 1, Chap-  
8 ter 163, Laws of 2013, and any other appropriation provided for by law, there  
9 is hereby appropriated to the Medical Boards, the following amounts to be  
10 expended for the designated programs and expense classes, from the listed  
11 funds for the period July 1, 2013, through June 30, 2014:

1           SECTION 2. Notwithstanding any other provision of law to the contrary,  
2 the appropriation made to the Medical Boards for the Board of Veterinary  
3 Medicine in Section 1, Chapter 163, Laws of 2013, from the State Regulatory  
4 Fund, is hereby reduced by \$17,800 for operating expenditures, for the pe-  
5 riod July 1, 2013, through June 30, 2014.

6           SECTION 3. An emergency existing therefor, which emergency is hereby  
7 declared to exist, this act shall be in full force and effect on and after its  
8 passage and approval.
