HOUSE BILL NO. 495

BY AGRICULTURAL AFFAIRS COMMITTEE

AN ACT

1 RELATING TO THE DAIRY PRODUCTS COMMISSION; AMENDING SECTION 25-3108, IDAHO  
2 CODE, TO SPECIFY THAT CERTAIN PROVISIONS ARE NOTWITHSTANDING DESIG-  
3 NATED LAW, TO REVISE COMPENSATION AND REIMBURSEMENT PROVISIONS AND TO  
4 PROVIDE THAT MEMBERS OF THE DAIRY PRODUCTS COMMISSION SHALL FIX THE COM-  
5 PENSATION AND REIMBURSEMENT THEY SHALL RECEIVE; AND AMENDING SECTION  
6 25-3112, IDAHO CODE, TO REVISE THE TIME IN WHICH THE COMMISSION SHALL  
7 FILE A SPECIFIED ANNUAL REPORT WITH DESIGNATED ENTITIES.

9 Be It Enacted by the Legislature of the State of Idaho:

10 SECTION 1. That Section 25-3108, Idaho Code, be, and the same is hereby  
11 amended to read as follows:

12 25-3108. SALARY. Notwithstanding the provisions of section 59-509,  
13 Idaho Code, members of the commission shall be compensated as provided by  
14 section 59-509(h), Idaho Code fix the compensation they shall each receive  
15 for their services, not to exceed the sum of one hundred fifty dollars (\$150)  
16 per day, and shall fix the reimbursement they shall each receive for their  
17 travel and their necessary expenses for each day they shall be away from  
18 their place of residence and engaged in the business of their office, subject  
19 to the limits provided in section 67-2008, Idaho Code.

20 SECTION 2. That Section 25-3112, Idaho Code, be, and the same is hereby  
21 amended to read as follows:

22 25-3112. DEPOSIT AND DISBURSEMENT OF FUNDS. (1) Immediately upon re-  
23 ceipt, all moneys received by the commission shall be deposited in one or  
24 more separate accounts in the name of the commission in one or more banks or  
25 trust companies approved under chapter 27, title 67, Idaho Code, as state de-  
26 positories. The commission shall designate such banks or trust companies.  
27 All funds so deposited are hereby continuously appropriated for the purpose  
28 of carrying out the provisions of this chapter.

29 (2) Funds can be withdrawn or paid out of such accounts only upon checks  
30 or other orders upon such accounts signed by two (2) officers designated by  
31 the commission.

32 (3) The right is reserved to the state of Idaho to audit the funds of the  
33 commission at any time.

34 (4) ~~On or before January 15 of e~~Each year, during the legislative ses-  
35 sion, the commission shall file with the senate agricultural affairs com-  
36 mittee, the house agricultural affairs committee, the legislative services  
37 office, the state controller, and the division of financial management, a  
38 report showing the annual income and expenses by standard classification of  
39 the commission during the preceding fiscal year. The report shall also in-  
40 clude an estimate of income to the commission for the current and next fiscal

1 year and a projection of anticipated expenses by category for the current and  
2 next fiscal year. From and after January 15, 1989, the report shall also in-  
3 clude a reconciliation between the estimated income and expenses projected  
4 and the actual income and expenses of the preceding fiscal year.

5 (5) All moneys received or expended by the commission shall be audited  
6 annually by a certified public accountant designated by the commission, who  
7 shall furnish a copy of such audit to the director of legislative services  
8 and to the senate agricultural affairs committee and the house agricultural  
9 affairs committee. The audit shall be completed within ninety (90) days fol-  
10 lowing the close of the fiscal year.

11 (6) The expenditures of the commission are expressly exempted from the  
12 provisions of sections 67-2007 and 67-2008, Idaho Code.
