

## STATEMENT OF PURPOSE

### RS23080

This is the FY 2015 appropriation to the Idaho State Historical Society for \$2,589,100 from the General Fund, \$1,550,900 in dedicated funds, and \$1,495,600 in federal funds for a total of \$5,635,600. Full-time equivalent positions are capped at 49.02. It includes \$70,700 in benefit cost increases, \$2,900 in contract inflation, \$124,400 for replacement items, a reduction in \$18,200 for statewide cost allocation, and \$52,800 for an increase in employee compensation.

The bill also includes \$94,500 from the General Fund to maintain the state's historical buildings and grounds by filling one vacant FTP with a maintenance craftsman employee. It also increases the agency's operating budget to pay for contract services such as lawn care, snow plowing, and HVAC monitoring. The second line item in this bill is for \$160,000 in federal funds for a two-year federal grant. The first nine months of operating expenditures for the grant were appropriated in FY 2014. This appropriation covers the projected expenditures in FY 2015. The grant runs from September 2013 - September 2015. This grant pays for the agency's work to digitize 50,000 pages of Idaho territorial newspapers, dating from 1864-1890, with searchable keyword functions for free online public access. The digitized newspapers will be on the web pages of the Library of Congress and the Idaho State Historical Society. Lastly, this bill provides \$800 for IT-related billing fees, for a total FY 2015 appropriation to the Idaho State Historical Society for \$5,635,600.
