3 ADDITION OF A NEW SECTION 39-3121, IDAHO CODE, TO PROVIDE A DECLARATION
4 OF POLICY; AMENDING CHAPTER 31, TITLE 39, IDAHO CODE, BY THE ADDITION
5 OF A NEW SECTION 39-3122, IDAHO CODE, TO PROVIDE DEFINITIONS; REPEALING
6 SECTION 39-3123, IDAHO CODE, RELATING TO DECLARATION OF POLICY; AMEND-

34 REGIONAL BEHAVIORAL HEALTH BOARDS; REPEALING SECTION 39-3133, IDAHO
35 CODE, RELATING TO DUTIES OF THE DIRECTOR OF THE DEPARTMENT OF HEALTH
36 AND WELFARE; AMENDING CHAPTER 31, TITLE 39, IDAHO CODE, BY THE ADDITION
37 OF A NEW SECTION 39-3133, IDAHO CODE, TO PROVIDE FOR THE ESTABLISHMENT
38 OF AN EXECUTIVE COMMITTEE OF THE REGIONAL BEHAVIORAL HEALTH BOARDS AND
39 TO PROVIDE FOR POWERS AND DUTIES OF THE COMMITTEE; REPEALING SECTION
40 39-3134, IDAHO CODE, RELATING TO COORDINATION OF SERVICES BETWEEN RE-
41 GIONS AND STATE; AMENDING SECTION 39-3130, IDAHO CODE, TO REDESIGNATE
42 THE SECTION, TO REVISE TERMINOLOGY AND TO PROVIDE FOR MEMBERS, TERMS
43 AND APPOINTMENTS FOR THE REGIONAL BEHAVIORAL HEALTH BOARDS; REPEALING
44 SECTION 39-3134A, IDAHO CODE, RELATING TO COOPERATIVE SERVICE PLAN COM-

1 39-3122. DEFINITIONS. (1) "Behavioral health" means an integrated
2 system for evaluation and treatment of mental health and substance use dis-
3 orders.

4 (2) "Region" means the administrative regions as defined by the depart-
5 ment of health and welfare. Two (2) or more regions may consolidate for the
6 purposes of this chapter. For the purposes of this chapter, regions will be
7 consistent with judicial districts.

8 SECTION 4. That Section 39-3123, Idaho Code, be, and the same is hereby
9 repealed.

10 SECTION 5. That Section 39-3124, Idaho Code, be, and the same is hereby
11 amended to read as follows:

12 39-31243. DESIGNATION OF STATE MENTAL HEALTH AUTHORITY AND STATE SUB-
13 STANCE USE DISORDER AUTHORITY. The Idaho department of health and welfare is
14 hereby designated the state mental health authority and the state substance
15 use disorder authority, hereinafter referred to as the state behavioral
16 health authority. The state ~~mental~~ behavioral health authority is respon-
17 sible for overseeing the state of Idaho's behavioral health system of care.
18 The department shall fulfill this role through a collaborative process,
19 taking into consideration and incorporating whenever reasonably possible
20 the recommendations and evaluations of the state behavioral health planning
21 council ~~on mental health~~ and the regional ~~mental~~ behavioral health boards
22 in all statewide efforts to expand, improve, modify or transform the ~~mental~~
23 behavioral health service delivery system of the state. ~~The state mental~~
24 ~~health authority shall identify the resources necessary for these efforts to~~
25 ~~be implemented on a statewide basis~~ The provisions of this section shall not
26 prohibit appropriations to executive agencies or the judiciary to fund com-
27 munity-based behavioral health treatment within their target population.
28 The behavioral health authority shall report utilization, performance, out-
29 come and other quality assurance data to the state behavioral health plan-
30 ning council and the regional behavioral health board on an annual basis.

31 SECTION 6. That Chapter 31, Title 39, Idaho Code, be, and the same is
32 hereby amended by the addition thereto of a NEW SECTION, to be known and des-
33 ignated as Section 39-3124, Idaho Code, and to read as follows:

34 39-3124. IDAHO BEHAVIORAL HEALTH COOPERATIVE. The behavioral health
35 authority shall establish the Idaho behavioral health cooperative to advise
36 it on issues related to the coordinated delivery of community-based behav-
37 ioral health services. The membership shall include representatives from
38 the Idaho state judiciary, the Idaho department of correction, the Idaho de-
39 partment of juvenile corrections, the office of drug policy, the Idaho asso-
40 ciation of counties, the state behavioral health planning council, an adult
41 consumer of services, a family member of a youth consumer of services, the
42 state department of education and the Idaho department of health and wel-
43 fare, at a minimum, but may also include other members as deemed necessary
44 by the behavioral health authority. The Idaho behavioral health cooperative
45 shall meet quarterly, with additional meetings called at the request of the
46 state behavioral health authority.

1 SECTION 7. That Section 39-3125, Idaho Code, be, and the same is hereby
2 amended to read as follows:

3 39-3125. STATE BEHAVIORAL HEALTH PLANNING COUNCIL ON MENTAL
4 HEALTH. (1) A state behavioral health planning council, hereinafter re-
5 ferred to as the planning council, shall be established to serve as an
6 advocate for children and adults with a severe mental illness and for seri-
7 ously emotionally disturbed children and youth behavioral health disorders;
8 to advise the state mental behavioral health authority on issues of concern,
9 on policies and on programs and to provide guidance to the mental state be-
10 havioral health authority in the development and implementation of the state
11 mental behavioral health systems plan; to monitor and evaluate the alloca-
12 tion and adequacy of mental behavioral health services within the state on
13 an ongoing basis; to monitor and evaluate the effectiveness of state laws
14 that address behavioral health services; to ensure that individuals with
15 severe mental illness and serious emotional disturbances behavioral health
16 disorders have access to prevention, treatment, prevention and rehabil-
17 itation services including those services that go beyond the traditional
18 mental health system; to serve as a vehicle for intra-agency and interagency
19 policy and program development; and to present to the governor, the judi-
20 ciary and the legislature by June 30 of each year a report on the council's
21 achievements activities and the impact on the quality of life that mental an
22 evaluation of the current effectiveness of the behavioral health services
23 has on citizens of provided directly or indirectly by the state to adults
24 and children. The planning council shall establish readiness and perfor-
25 mance criteria for the regional boards to accept and maintain responsibility
26 for family support and recovery support services. The planning council
27 shall evaluate regional board adherence to the readiness criteria and make
28 a determination if the regional board has demonstrated readiness to accept
29 responsibility over the family support and recovery support services for the
30 region. The planning council shall report to the behavioral health author-
31 ity if it determines a regional board is not fulfilling its responsibility to
32 administer the family support and recovery support services for the region
33 and recommend the regional behavioral health centers assume responsibility
34 over the services until the board demonstrates it is prepared to regain the
35 responsibility.

36 (2) The planning council shall be appointed by the governor and be com-
37 prised of no ~~less~~ more than fifty percent (50%) ~~family members and consumers~~
38 ~~with mental illness~~ state employees or providers of behavioral health ser-
39 vices. Membership shall also reflect to the extent possible the collective
40 demographic characteristics of Idaho's citizens. The planning council
41 membership shall strive to include representation from consumers, families
42 of adults individuals with severe serious mental illness or substance use
43 disorders; behavioral health advocates; families of children or youth with
44 serious emotional disturbance; principal state agencies including and the
45 judicial branch with respect to mental behavioral health, education, voca-
46 tional rehabilitation, eriminal justice adult correction, juvenile justice
47 and law enforcement, title XIX of the social security act and other entitle-
48 ment programs; public and private entities concerned with the need, plan-
49 ning, operation, funding and use of mental health services or substance use

1 disorders, and related support services; and the regional ~~mental~~ behavioral
 2 health board in each department of health and welfare region as provided for
 3 in section 39-31304, Idaho Code. The planning council may include members of
 4 the legislature and the state judiciary.

5 (3) The planning council members will serve a term of two (2) years or
 6 at the pleasure of the governor, provided however, that of the members first
 7 appointed, one-half (1/2) of the appointments shall be for a term of one (1)
 8 year and one-half (1/2) of the appointments shall be for a term of two (2)
 9 years. The governor will appoint a chair and a vice-chair whose terms will be
 10 two (2) years.

11 (4) The council may establish subcommittees at its discretion.

12 SECTION 8. That Section 39-3126, Idaho Code, be, and the same is hereby
 13 amended to read as follows:

14 39-3126. DESIGNATION OF REGIONS FOR COMPREHENSIVE MENTAL REGIONAL
 15 BEHAVIORAL HEALTH SERVICES CENTERS. Recognizing both the ~~right~~ need of
 16 every citizen to receive the best ~~mental~~ behavioral health services that
 17 the state is able to provide within budgetary confines and the dispropor-
 18 tionate ability of counties to finance mental behavioral health services,
 19 the state mental behavioral health authority shall designate regions and
 20 be responsible for establishing regional comprehensive mental behavioral
 21 health services centers for all areas of the state. In the establishment of
 22 regions, primary consideration will be given to natural population group-
 23 ings and ~~trading~~ service areas, the regions previously designated for the
 24 establishment of other health services, the mental behavioral health needs
 25 of the people within the proposed regions, and the appropriate maximal use
 26 of available funding.

27 SECTION 9. That Chapter 31, Title 39, Idaho Code, be, and the same is
 28 hereby amended by the addition thereto of a NEW SECTION, to be known and des-
 29 ignated as Section 39-3127, Idaho Code, and to read as follows:

30 39-3127. COORDINATION OF SERVICES BETWEEN REGIONS AND STATE. The di-
 31 rector of the department of health and welfare shall coordinate services
 32 between the regional behavioral health centers, regional behavioral health
 33 boards and the state psychiatric hospitals.

34 SECTION 10. That Chapter 31, Title 39, Idaho Code, be, and the same is
 35 hereby amended by the addition thereto of a NEW SECTION, to be known and des-
 36 ignated as Section 39-3128, Idaho Code, and to read as follows:

37 39-3128. FACILITIES FOR BEHAVIORAL HEALTH CENTERS. The state behav-
 38 ioral health authority may contract for the lease of facilities appropri-
 39 ate for the establishment of behavioral health centers. In order to encour-
 40 age the development of comprehensive and integrated health care and whenever
 41 feasible and consistent with behavioral health treatment, these facilities
 42 shall be in or near facilities within the region housing other health ser-
 43 vices.

1 SECTION 11. That Section 39-3129, Idaho Code, be, and the same is hereby
2 repealed.

3 SECTION 12. That Chapter 31, Title 39, Idaho Code, be, and the same is
4 hereby amended by the addition thereto of a NEW SECTION, to be known and des-
5 ignated as Section 39-3129, Idaho Code, and to read as follows:

6 39-3129. DIVISION ADMINISTRATOR FOR REGIONAL BEHAVIORAL HEALTH CEN-
7 TERS -- DUTIES. The director of the department of health and welfare shall
8 appoint a division administrator to manage the regional behavioral health
9 centers and shall supervise its program; shall prescribe uniform standards
10 of treatment, services and care provided by the regional behavioral health
11 centers and regional behavioral health boards; shall set the professional
12 qualifications for staff positions; and make such other policy as are neces-
13 sary and proper to carry out the purposes and intent of this chapter.

14 SECTION 13. That Section 39-3127, Idaho Code, be, and the same is hereby
15 amended to read as follows:

16 39-312730. RECIPROCAL AGREEMENTS BETWEEN STATES TO SHARE SERVICES. In
17 such regions where natural population groupings overlap state boundaries,
18 ~~a~~ an interstate regional comprehensive mental behavioral health service
19 may be established jointly with a neighboring state or states. In such
20 instances, the state ~~mental behavioral~~ health authority may enter into re-
21 ciprocal agreements with these states to either share the expenses of the
22 service in proportion to the population served; to allow neighboring states
23 to buy services from Idaho; or to allow Idaho to purchase services that are
24 otherwise not available to ~~her~~ its citizens.

25 SECTION 14. That Section 39-3131, Idaho Code, be, and the same is hereby
26 repealed.

27 SECTION 15. That Section 39-3128, Idaho Code, be, and the same is hereby
28 amended to read as follows:

29 39-312831. BEHAVIORAL HEALTH SERVICES TO BE OFFERED. ~~A~~ The regional
30 ~~mental behavioral health service center shall include one (1) or more of the~~
31 provide or arrange for the delivery of services that, combined with commu-
32 nity family support and recovery support services provided through the re-
33 gional behavioral health boards, medicaid and services delivered through a
34 private provider network, will leading to the establishment of a regional
35 comprehensive mental regional behavioral health center system of care that
36 incorporates patient choice and family involvement to the extent reasonably
37 practicable and medically and professionally appropriate. ~~A comprehensive~~
38 ~~mental~~ The regional behavioral health center may include such shall provide
39 or arrange for the delivery of the following services as:

- 40 ~~(1) Short-term hospitalization for psychiatric treatment in an ap-~~
41 ~~proved medical facility within the region;~~
42 ~~(2) Partial hospitalization;~~
43 ~~(3) Outpatient diagnosis and treatment;~~
44 ~~(4) 24-hour emergency psychiatric services;~~

- 1 ~~(5) Community consultation and education;~~
2 ~~(6) Diagnostic services for other agencies;~~
3 ~~(7) Rehabilitative services;~~
4 ~~(8) Precare and postcare services in cooperation with a state mental~~
5 ~~hospital;~~
6 ~~(9) Training of mental health personnel;~~
7 ~~(10) Research and evaluation;~~
8 ~~(11) Transitional housing for individuals, including juveniles, with~~
9 ~~mental illness and/or addiction disorders to promote and sustain the ability~~
10 ~~of these individuals to live in the community and avoid institutionaliza-~~
11 ~~tion; and~~
12 ~~(12) Intensive supportive services such as those delivered by assertive~~
13 ~~community treatment teams. Assertive community treatment teams provide in-~~
14 ~~dividualized treatment, rehabilitation and support services to the severely~~
15 ~~and persistently mentally ill.~~
- 16 (1) Treatment services for individuals who do not have other benefits
17 available to meet their behavioral health needs as resources allow includ-
18 ing, but not limited to, psychiatric services, medication management, re-
19 habilitative and community-based services, outpatient and intensive outpa-
20 tient services, assertive community treatment, case management and residen-
21 tial care;
- 22 (2) Community family support and recovery support services as defined
23 in section 39-3135(7), Idaho Code, until the regional behavioral health
24 board can meet the initial readiness criteria and voluntarily accepts re-
25 sponsibility for these services or if the regional behavioral health board
26 fails to sustain criteria to maintain responsibility for these services;
- 27 (3) Evaluation and intervention for individuals experiencing a behav-
28 ioral health emergency;
- 29 (4) Hospital precare and postcare services, in cooperation with state
30 and community psychiatric hospitals, for individuals who have been commit-
31 ted to the custody of the director of health and welfare pursuant to sections
32 18-212 and 66-329, Idaho Code, or who are under an involuntary treatment or-
33 der pursuant to chapter 24, title 16, Idaho Code;
- 34 (5) Evaluation and securing mental health treatment services as or-
35 dered by a court for individuals pursuant to section 19-2524, 20-511A or
36 20-519B, Idaho Code; and
- 37 (6) Evaluation and securing treatment services for individuals who are
38 accepted into mental health courts.

39 SECTION 16. That Chapter 31, Title 39, Idaho Code, be, and the same is
40 hereby amended by the addition thereto of a NEW SECTION, to be known and des-
41 ignated as Section 39-3132, Idaho Code, and to read as follows:

42 39-3132. REGIONAL BEHAVIORAL HEALTH BOARDS -- ESTABLISHMENT. There is
43 hereby created and established in each region a regional behavioral health
44 board. It is legislative intent that the regional behavioral health boards
45 operate and be recognized not as a state agency or department, but as gov-
46 ernmental entities whose creation has been authorized by the state, much in
47 the manner as other single purpose districts. However, the regional behav-
48 ioral health boards shall have no authority to levy taxes. For the purposes
49 of section 59-1302(15), Idaho Code, the seven (7) regional behavioral health

1 boards created pursuant to this chapter shall be deemed governmental enti-
 2 ties. The regional behavioral health boards are authorized to provide the
 3 community family support and recovery support services identified in sec-
 4 tion 39-3135(7), Idaho Code. The services identified in section 39-3135(7),
 5 Idaho Code, shall not be construed to restrict the services of the regional
 6 behavioral health board solely to these categories.

7 SECTION 17. That Section 39-3133, Idaho Code, be, and the same is hereby
 8 repealed.

9 SECTION 18. That Chapter 31, Title 39, Idaho Code, be, and the same is
 10 hereby amended by the addition thereto of a NEW SECTION, to be known and des-
 11 ignated as Section 39-3133, Idaho Code, and to read as follows:

12 39-3133. EXECUTIVE COMMITTEE OF THE REGIONAL BEHAVIORAL HEALTH
 13 BOARDS. Each regional behavioral health board shall annually elect from
 14 within its membership an executive committee of five (5) members empowered
 15 to make fiscal, legal and business decisions on behalf of the full board or
 16 join with another governmental entity that can fulfill the same management
 17 infrastructure function. If the regional behavioral health board elects to
 18 create its own internal executive committee, the membership shall be repre-
 19 sentative of the regional behavioral health board membership and must, at
 20 a minimum, include one (1) mental health consumer or advocate and one (1)
 21 substance use disorder consumer or advocate. The executive committees or
 22 the partner public entity shall have the power and duty, on behalf of the
 23 regional behavioral health boards, to:

24 (1) Establish a fiscal control policy as required by the state con-
 25 troller;

26 (2) Enter into contracts and grants with other governmental and private
 27 agencies, and this chapter hereby authorizes such other agencies to enter
 28 into contracts with the regional behavioral health boards, as deemed neces-
 29 sary to fulfill the duties imposed upon the board to promote and sustain the
 30 ability of individuals with behavioral health disorders to live in the com-
 31 munity and avoid institutionalization;

32 (3) Develop and maintain bylaws as necessary to establish the process
 33 and structure of the board; and

34 (4) Employ and fix the compensation, subject to the provisions of chap-
 35 ter 53, title 67, Idaho Code, of such personnel as may be necessary to carry
 36 out the duties of the regional behavioral health boards.

37 All meetings of the executive committee shall be held in accordance with
 38 the open meeting law as provided for in chapter 23, title 67, Idaho Code.

39 SECTION 19. That Section 39-3134, Idaho Code, be, and the same is hereby
 40 repealed.

41 SECTION 20. That Section 39-3130, Idaho Code, be, and the same is hereby
 42 amended to read as follows:

43 39-31304. REGIONAL MENTAL BEHAVIORAL HEALTH BOARD -- MEMBERS -- TERMS
 44 -- APPOINTMENT. A regional mental behavioral health board for each region
 45 shall consist of seventeen twenty-two (1722) members is hereby created

1 and shall be appointed as provided herein. All meetings of the regional
 2 behavioral health board shall be held in accordance with the open meeting
 3 law as provided for in chapter 23, title 67, Idaho Code. Members shall be
 4 qualified electors and shall represent comprised of the following: three
 5 (3) county commissioners or their designee; two (2) department of health and
 6 welfare employees who represent the mental behavioral health system within
 7 the region; two one (21) parents of a children with a serious emotional dis-
 8 turbance, as defined in section 16-2403, Idaho Code, provided each parent's
 9 respective child is no older than twenty-one (21) years of age at the time of
 10 appointment; one (1) parent of a child with a substance use disorder; a law
 11 enforcement officer; three one (31) adult mental health services consumer
 12 representatives, advocates or family members; one (1) mental health advo-
 13 cate; one (1) substance use disorder advocate; one (1) adult substance use
 14 disorder services consumer representative; one (1) family member of an adult
 15 mental health services consumer; one (1) family member of an adult substance
 16 use disorder services consumer; a private provider of mental health services
 17 within the region; a private provider of substance use disorder services
 18 within the region; a representative of the elementary or secondary public
 19 education system within the region; a representative of the juvenile justice
 20 system within the region; a representative of the adult correction system
 21 within the region; a representative of the judiciary appointed by the admin-
 22 istrative district judge; a physician or other licensed health practitioner
 23 from within the region; and a representative of a hospital within the region;
 24 and a member of the regional advisory substance abuse authority. The con-
 25 sumer, parent and family representatives shall be selected from nominations
 26 submitted by mental behavioral health consumer and advocacy organizations.
 27 The board may have nonvoting members as necessary to fulfill its roles and
 28 responsibilities. The board shall meet at least twice each year, and shall
 29 annually elect a chairperson and other officers as it deems appropriate.

30 On the effective date of this chapter, tThe appointing authority in
 31 each region shall be a committee composed of the chairperson of the board of
 32 county commissioners of each of the counties within the region, the regional
 33 mental health program manager for the department of health and welfare and
 34 the regional director for the current chair of the regional mental health
 35 board and the current chair of the regional advisory committee and, after
 36 the initial appointment of members to the regional behavioral health board,
 37 the current chair of the regional behavioral health board and one (1) repre-
 38 sentative of the department of health and welfare. The committee shall meet
 39 annually or as needed to fill vacancies on the board. The list of appoint-
 40 ments shall be submitted to the department of health and welfare.

41 The appointing authority in each region shall determine if mMembers of
 42 the regional mental health advisory board and the regional advisory commit-
 43 tee who are serving on the effective date of this act chapter may continue
 44 to serve until the end of the current term of their appointment- or they may
