AN ACT

1 RELATING TO DEPARTMENT OF CORRECTION APPROPRIATIONS AND TRANSFERS; APPRO-
2 PRIATING ADDITIONAL MONEYS TO THE DEPARTMENT OF CORRECTION FOR THE
3 MANAGEMENT SERVICES PROGRAM FOR FISCAL YEAR 2014; APPROPRIATING AD-
4 DITIONAL MONEYS TO THE DEPARTMENT OF CORRECTION FOR THE CORRECTIONAL
5 ALTERNATIVE PLACEMENT PROGRAM FOR FISCAL YEAR 2014; APPROPRIATING
6 ADDITIONAL MONEYS TO THE DEPARTMENT OF CORRECTION FOR THE COUNTY AND
7 OUT-OF-STATE PLACEMENT PROGRAM FOR FISCAL YEAR 2014; APPROPRIATING AND
8 TRANSFERRING CERTAIN MONEYS FROM THE SUPREME COURT TO THE DEPARTMENT
9 OF CORRECTION FOR FISCAL YEAR 2014; APPROPRIATING ADDITIONAL MONEYS TO
10 THE DEPARTMENT OF CORRECTION FOR THE COMMUNITY-BASED SUBSTANCE ABUSE
11 TREATMENT PROGRAM FOR FISCAL YEAR 2014; APPROPRIATING ADDITIONAL MON-
12 EYS TO THE DEPARTMENT OF CORRECTION FOR THE MEDICAL SERVICES PROGRAM
13 FOR FISCAL YEAR 2014; REDUCING THE APPROPRIATION TO THE DEPARTMENT OF
14 CORRECTION FOR PRIVATE PRISONS FOR FISCAL YEAR 2014; AND DECLARING AN
15 EMERGENCY.

17 Be It Enacted by the Legislature of the State of Idaho:

18 SECTION 1. In addition to the appropriation made in Section 3, Chapter
19 318, Laws of 2013, and any other appropriation provided for by law, there is
20 hereby appropriated \$200,000 from the General Fund to the Department of Cor-
21 rection, for the Management Services Program, to be expended for operating
22 expenditures, for the period July 1, 2013, through June 30, 2014, for the
23 purpose of covering the cost of legal fees in the Walter D. Balla et al. v.
24 Idaho State Board of Correction et al. court case.

25 SECTION 2. In addition to the appropriation made in Section 3, Chapter
26 318, Laws of 2013, and any other appropriation provided for by law, there is
27 hereby appropriated \$40,600 from the General Fund to the Department of Cor-
28 rection, for the Correctional Alternative Placement Program, to be expended
29 for operating expenditures, for the period July 1, 2013, through June 30,
30 2014, for the purpose of housing additional inmates at that facility.

31 SECTION 3. In addition to the appropriation made in Section 3, Chapter
32 318, Laws of 2013, and any other appropriation provided for by law, there is
33 hereby appropriated \$407,500 from the General Fund to the Department of Cor-
34 rection, for the County and Out-of-State Placement Program, to be expended
35 for operating expenditures, for the period July 1, 2013, through June 30,
36 2014, for the purpose of covering the cost of housing inmates in county jails
37 or in out-of-state facilities.

38 SECTION 4. There is hereby appropriated, and the State Controller shall
39 transfer, as soon as practicable, the sum of \$943,425.60 from the Substance

1 Abuse Treatment Fund within the Supreme Court to the Substance Abuse Treat-
2 ment Fund within the Department of Correction.

3 SECTION 5. In addition to the appropriation made in Section 3, Chapter
4 318, Laws of 2013, and any other appropriation provided for by law, there is
5 hereby appropriated \$818,900 from the Substance Abuse Treatment Fund to the
6 Department of Correction, for the Community-Based Substance Abuse Treatment
7 Program, to be expended for trustee and benefit payments, for the period July
8 1, 2013, through June 30, 2014, for the purpose of providing substance abuse
9 treatment to eligible offenders.

10 SECTION 6. In addition to the appropriation made in Section 3, Chapter
11 318, Laws of 2013, and any other appropriation provided for by law, there is
12 hereby appropriated to the Department of Correction, for the Medical Ser-
13 vices Program, the following amount to be expended for operating expendi-
14 tures, from the listed funds for the period July 1, 2013, through June 30,
15 2014, for the purpose of covering the cost of inmate medical care that is pro-
16 vided under contract with Corizon Health, Incorporated.

21 SECTION 7. Notwithstanding any other provision of law to the contrary,
22 the appropriation of moneys made to the Department of Correction for Private
23 Prisons in Section 3, Chapter 318, Laws of 2013, from the General Fund, is
24 hereby reduced by \$502,300 for operating expenditures, for the period July
25 1, 2013, through June 30, 2014, for the purpose of removing one-time savings
26 at the privately operated Idaho Correctional Center.

27 SECTION 8. An emergency existing therefor, which emergency is hereby
28 declared to exist, this act shall be in full force and effect on and after its
29 passage and approval.
