HOUSE AMENDMENT TO S.B. NO. 1395

AMENDMENT TO THE BILL

On page 1 of the printed bill, delete lines 9 through 42; and delete pages 2 and 3, and insert:

"SECTION 1. That Section 59-501, Idaho Code, be, and the same is hereby amended to read as follows:

59-501. SALARIES OF STATE ELECTIVE OFFICERS -- REGULAR PAYMENT -- TRAVELING EXPENSES -- FEES PROPERTY OF STATE. (1) The governor, lieutenant governor, secretary of state, state controller, state treasurer, attorney general and superintendent of public instruction shall, during their continuance in office, receive for their services compensation as follows:

Commencing on the first Monday in January 2014~~5~~5, until the first Monday in January 201~~26~~26:

Governor, \$~~110,734~~120,785 per annum;

Lieutenant governor, \$~~29,184~~42,275 per annum;

Secretary of state, \$~~90,006~~102,667 per annum;

State controller, \$~~90,006~~102,667 per annum; said compensation to be audited by the legislative council;

~~Attorney general, \$99,825 per annum;~~

State treasurer, \$~~90,006~~102,667 per annum; and

State superintendent of public instruction, \$~~90,006~~102,667 per annum.

(2) The governor, lieutenant governor, secretary of state, state controller, state treasurer, ~~attorney general~~ and superintendent of public instruction shall, during their continuance in office, receive for their services compensation as follows:

Commencing on the first Monday in January 201~~26~~26, until the first Monday in January 201~~37~~37:

Governor, \$~~115,348~~122,597 per annum;

Lieutenant governor, \$~~30,400~~42,909 per annum;

Secretary of state, \$~~93,756~~104,207 per annum;

State controller, \$~~93,756~~104,207 per annum; said compensation to be audited by the legislative council;

~~Attorney general, \$103,984 per annum;~~

State treasurer, \$~~93,756~~104,207 per annum; and

State superintendent of public instruction, \$~~93,756~~104,207 per annum.

(3) Commencing on the first Monday in January 201~~37~~37, until the first Monday in January 201~~48~~48, the governor shall receive for his services compensation of \$~~117,000~~124,436 per annum; and each officer named in subsection

(2) of this section, except for the governor and attorney general, shall receive the following compensation for their services:

15 (4) Commencing on the first Monday in January 2014~~8~~⁹, until the first
16 Monday in January 2015~~9~~⁹, the governor shall receive for his services compen-
17 sation of \$~~119,000~~^{126,302} per annum; and each officer named in subsection
18 (3) of this section, except for the governor and attorney general, shall re-
19 ceive the following compensation for their services:

20 Lieutenant governor, thirty-five percent (30~~5~~%) of the governor's com-
21 pensation as provided for in this subsection, per annum;

22 Secretary of state, eighty-five percent (85%) of the governor's compen-
23 sation as provided for in this subsection, per annum;

24 State controller, eighty-five percent (85%) of the governor's compen-
25 sation as provided for in this subsection, per annum; said compensation to be
26 audited by the legislative council;

27 ~~Attorney general, ninety percent (90%) of the governor's compensation~~

34 (5) Prior to the start of the next term of office for the attorney gen-
35 eral, the attorney general's salary shall be increased to match that of a
36 district judge as provided in section 59-502, Idaho Code, on December 31 of
37 the last year of the attorney general's term of office. Such increase shall
38 take effect on the first Monday in January of the attorney general's term of
39 office.

40 (6) Such compensation shall be paid on regular pay periods as due out of
41 the state treasury, and shall be in full for all services by said officers re-
42 spectively rendered in any official capacity or employment whatever during
43 their respective terms of office; but no increase in the rate of compensation
44 shall be made during the terms of such officers; provided, however, that the
45 actual and necessary expenses of the governor, lieutenant governor, secre-
46 tary of state, attorney general, state controller, state treasurer, and su-
47 perintendent of public instruction while traveling within the state, or be-
48 tween points within the state, in the performance of official duties, shall
49 be allowed and paid by the state; not however, exceeding such sum as shall be
50 appropriated for such purpose.

1 (67) Actual and necessary subsistence expenses of the governor while
2 traveling in connection with the performance of official duties are hereby
3 expressly exempted from the provisions of sections 67-2007 and 67-2008,
4 Idaho Code. (Standard Travel Pay and Allowance Act of 1949).

5 (78) No officer named in this section shall receive, for the perfor-
6 mance of any official duty any fee for his own use, but all fees fixed by law
7 for the performance by either of them, of any official duty, shall be col-
8 lected in advance and deposited with the state treasurer to the credit of the
9 state.".
