**Chairman Denney** requested volunteers for proofreading of the minutes. **Rep. Pence** and **Rep. Boyle** volunteered to be proofreaders.

**Chairman Denney** said the rules will be reviewed as a whole committee and requested representatives review the rules and identify rules requiring more time or possible controversy.

**Representative Miller** acknowledged his son in the audience and stated his son is visiting and just completed his masters degree in engineering.

**Chairman Denney** identified **Rep. IIana Rubel** and welcomed her to the Committee.

**Jack Lyman**, Idaho Mining Association, gave a presentation and said the mining industry employs 9,000 Idaho employees, provides 500 million in economic activity, and provides good paying jobs. Mining adds jobs and benefits to the economy. Mr. Lyman stated permitting of mines is a long process.

In response to committee questions, **Mr. Lyman** said if the Federal lands in the State were state-owned, some changes for the mining industry would be the elimination of the Environmental Impact Statement requirement. He said the state would also allow competition in mining claims.
