The Legislative Services Office, Research and Legislation, has received the enclosed rules of the
Office of the Governor - Military Division - Bureau of Homeland Security:

IDAPA 15.06.03 - Public safety communications systems installation and maintenance fee rules -
Proposed Rule (Docket No. 15-0603-1501).

Pursuant to Section 67-454, Idaho Code, a meeting on the enclosed rules may be called by the
cochairmen or by two (2) or more members of the subcommittee giving oral or written notice to Research
and Legislation no later than fourteen (14) days after receipt of the rules' analysis from Legislative
Services. The final date to call a meeting on the enclosed rules is no later than 09/16/2015. If a meeting is
called, the subcommittee must hold the meeting within forty-two (42) days of receipt of the rules' analysis
from Legislative Services. The final date to hold a meeting on the enclosed rules is 10/15/2015.

The germane joint subcommittee may request a statement of economic impact with respect to a
proposed rule by notifying Research and Legislation. There is no time limit on requesting this statement,
and it may be requested whether or not a meeting on the proposed rule is called or after a meeting has
been held.

IDAPA 15.06.03 - Public safety communications systems installation and maintenance fee rules - Proposed Rule (Docket No. 15-0603-1501)

The Idaho Military Division submits notice of proposed rulemaking at IDAPA 15.06.03 - Public safety communications systems installation and maintenance fee rules. The Idaho Military Division states that this rulemaking reflects organizational changes within the Division. The Public Safety Communications Branch is no longer tied to the Bureau of Homeland Security, and this rule updates information to reflect the new structure.

The Division states that negotiated rulemaking was not conducted because the proposed change is simple in nature. There is no fiscal impact associated with this rulemaking.

The proposed rule appears to be within the statutory authority granted to the Division in Section 46-804, Idaho Code.
