HOUSE BILL NO. 205

BY APPROPRIATIONS COMMITTEE

AN ACT

1 APPROPRIATING ADDITIONAL MONEYS TO THE DEPARTMENT OF HEALTH AND WELFARE FOR  
2 THE DIVISION OF MEDICAID FOR FISCAL YEAR 2015; REDUCING THE APPROPRIA-  
3 TION TO THE DEPARTMENT OF HEALTH AND WELFARE FOR THE DIVISION OF MEDIC-  
4 AID FOR FISCAL YEAR 2015; AND DECLARING AN EMERGENCY.

6 Be It Enacted by the Legislature of the State of Idaho:

7 SECTION 1. In addition to the appropriation made in Section 1, Chapter  
8 312, Laws of 2014, and any other appropriation provided for by law, there is  
9 hereby appropriated to the Department of Health and Welfare, for the Divi-  
10 sion of Medicaid, the following amounts to be expended for trustee and bene-  
11 fit payments for the designated programs, from the Cooperative Welfare (Ded-  
12 icated) Fund for the period July 1, 2014, through June 30, 2015:

18 SECTION 2. Notwithstanding any other provision of law to the contrary,  
19 the appropriation made to the Department of Health and Welfare for the Divi-  
20 sion of Medicaid, in Section 1, Chapter 312, Laws of 2014, is hereby reduced  
21 by the following amounts, for trustee and benefit payments according to  
22 the designated programs, from the listed funds for the period July 1, 2014,  
23 through June 30, 2015:
