AN ACT

1 RELATING TO THE IDAHO UNIFORM BUSINESS ORGANIZATIONS CODE; AMENDING SECTION  
2 30-21-214, IDAHO CODE, AS ADDED IN SECTION 8 OF SENATE BILL NO. 1025,  
3 AS ENACTED BY THE FIRST REGULAR SESSION OF THE SIXTY-THIRD IDAHO LEG-  
4 ISLATURE, TO REVISE A SURCHARGE FOR PROVIDING EVIDENCE OF A CERTAIN EN-  
5 TITY FILING AND TO REMOVE A PROVISION RELATING TO A SURCHARGE FOR CER-  
6 TAIN RECORDS.

8 Be It Enacted by the Legislature of the State of Idaho:

9 SECTION 1. That Section 30-21-214, Idaho Code, as added in Section 8 of  
10 Senate Bill No. 1025, as enacted by the First Regular Session of the Sixty-  
11 third Legislature Idaho Legislature, be, and the same is hereby amended to  
12 read as follows:

- 13 30-21-214. FEES. (a) The secretary of state shall collect the follow-  
14 ing fees for copying and certifying the copy of any filed record:  
15 (1) Twenty-five cents (25¢) per page for copying; and  
16 (2) Ten dollars (\$10.00) for the certification.  
17 (b) The secretary of state shall collect the following fees when an en-  
18 tity filing is delivered for filing:

38	(d) The secretary of state shall collect a surcharge of <del>twenty</del> <u>twenty five</u>	
39	dollars ( <del>\$250.00</del> ) for providing evidence of filing an entity filing within	
40	eight (8) working hours after the entity filing is delivered for filing.	
41	<del>(e) The secretary of state shall collect a surcharge of twenty dollars</del>	
42	<del>(\$20.00) for filing any non-typed record or any record that is not on a stan-</del>	
43	<del>dard form proscribed by the secretary of state, except no surcharge will be</del>	
44	<del>collected for a non-typed certificate of assumed business name or a certifi-</del>	
45	<del>cate of amendment to certificate of assumed business name.</del>
