	Chairman DeMordaunt recognized the service of Legislative Page, Janel Prigge, who has been assigned to the committee for the second half of the 2015 Legislative Session. He also recognized the service of Education Secretary, <b>Jean Vance</b> .

	<b>Tracie Bent</b> presented <b>RS 23950.</b> She explained the proposed legislation makes a technical correction to Section 33-515, Idaho Code. She said <b>S 1088</b> defines what constitutes a "reduction in force" and removes certain sunsets including a sunset on the current language in Section 33-515, Idaho Code, which is effective July, 1, 2015. The Career Ladder legislation, <b>H 296</b> , amends the renewable contract provision in Section 33-515, Idaho Code, that would have been effective July, 1, 2015, but for the passage of <b>S 1088</b> . She indicated the proposed legislation resolves this conflict by preserving the renewable contract provision pursuant to the changes in <b>S 1088</b> , and maintains the provision in <b>H 296</b> regarding the ability for instructional staff to obtain a renewable contract and professional endorsement.  In response to a question, <b>Ms. Bent</b> said if the Legislature fails to fund the Career Ladder in any fiscal year, then a professional endorsement shall not be required of the instructional staff in order to receive a renewable contract.
