NOTICE OF RULEMAKING – ADOPTION OF TEMPORARY RULE

EFFECTIVE DATE: The effective date of the temporary rule is December 15, 2016.

AUTHORITY: In compliance with Sections 67-5226, Idaho Code, notice is hereby given this agency has adopted a temporary rule. The action is authorized pursuant to Sections 33-105 and 33-1612, Idaho Code.

DESCRIPTIVE SUMMARY: The following is the required finding and concise statement of its supporting reasons for adopting a temporary rule:

The Idaho Content Standards reflect statements of what students should know and do in various content disciplines and grades. Content standards are adopted statewide and reviewed every six (6) years by teams of educators and stakeholders. These standards provide a consistent foundational level of academic content needed to be successful at each grade level and to graduate from Idaho’s public schools.

Idaho Administrative Code requires that students meet locally established standards, with state standards as a minimum. Because of the age of the current science standards and the delay in adopting revised standards, many Idaho school districts have already adopted more rigorous science standards.

The science standards went through the negotiated rulemaking process in April 2016 but did not go to the State Board of Education for adoption with the other revised content standards to allow for additional deliberation. The science standards committee reconvened in October 2016 to address and consider additional public comments and to reformat the science standards document. The revised document is being incorporated by reference in this temporary rule.

TEMPORARY RULE JUSTIFICATION: Pursuant to Section 67-5226(1)(c), Idaho Code, the Governor has found that temporary adoption of the rule is appropriate for the following reasons:

In order to meet the Constitutional requirement that the Legislature establish and maintain a ‘general, uniform and thorough system of public, free common schools,’ this temporary rule confers a benefit by reestablishing a common baseline in science education statewide.

FEE SUMMARY: Pursuant to Section 67-5226(2), the Governor has found that the fee or charge being imposed or increased is justified and necessary to avoid immediate danger and the fee is described herein: N/A
