2 RELATING TO RESIDENTIAL CARE FACILITY ADMINISTRATORS; REPEALING SECTION  
3 54-4208, IDAHO CODE, RELATING TO LICENSES AND EDUCATION AND TRAINING  
4 REQUIREMENTS; AND AMENDING SECTION 54-4209, IDAHO CODE, TO REVISE PRO-  
5 VISIONS REGARDING LICENSE RENEWAL AND REINSTATEMENT.

6 Be It Enacted by the Legislature of the State of Idaho:

7 SECTION 1. That Section [54-4208](#), Idaho Code, be, and the same is hereby  
8 repealed.

9 SECTION 2. That Section 54-4209, Idaho Code, be, and the same is hereby  
10 amended to read as follows:

11 54-4209. LICENSURE -- ~~ATTENDANCE AT CONTINUING EDUCATION PROGRAM --~~  
12 RENEWAL AND REINSTATEMENT OF LICENSES. ~~(1) Every individual who qualifies~~  
13 ~~for licensure by the board under section 54-4208(1), Idaho Code, shall be is-~~  
14 ~~sued a license. Thereafter, such individual shall annually be required to~~  
15 ~~apply to the board for a license renewal and report any facts requested by the~~  
16 ~~board on forms provided for such purpose. All licenses issued under the pro-~~  
17 ~~visions of this chapter shall be subject to annual renewal and shall expire~~  
18 ~~unless renewed in the manner prescribed by the board regarding applications~~  
19 ~~for renewal, continuing education, and fees. License renewal and reinstatement~~  
20 ~~shall be in accordance with as set forth in section 67-2614, Idaho Code.~~

21 ~~(2) Upon making an application for license renewal, each individual~~  
22 ~~shall pay an annual renewal fee, and submit proof of the satisfactory comple-~~  
23 ~~tion of the required continuing education as may be provided in the rules of~~  
24 ~~the board.~~

25 ~~(3) Upon receipt of the renewal application, the required fee, and the~~  
26 ~~proof of continuing education, the board shall issue a current license.~~

27 ~~(4) A residential care facility administrator who has been duly li-~~  
28 ~~icensed in this state and whose license has not been revoked or suspended,~~  
29 ~~and whose license has expired for a period of not longer than five (5) years,~~  
30 ~~may apply for the reinstatement of his license by filing with the board~~  
31 ~~an application together with proof of having met the continuing education~~  
32 ~~requirement within the previous twelve (12) months in accordance with the~~  
33 ~~rules of the board, and payment of a twenty-five dollar (\$25.00) reinstatement~~  
34 ~~fee together with the renewal fees for all lapsed years.~~

35 ~~(5) The board shall maintain a register of all applications for licens-~~  
36 ~~ing of residential care facility administrators, which register shall show:~~  
37 ~~The name and address of each applicant, the name and address of employer or~~  
38 ~~business connection of each applicant, the date of application, complete in-~~  
39 ~~formation of educational and experiential qualifications, the license issue~~  
40 ~~date, the license number, the certificate issue date, the date on which the~~
