44 Be It Enacted by the Legislature of the State of Idaho:

45 SECTION 1. That Section 36-2106, Idaho Code, be, and the same is hereby
 46 amended to read as follows:

47 36-2106. APPOINTMENT AND QUALIFICATION OF MEMBERS -- ORGANIZATION OF
 48 BOARD. One (1) member shall be a member of the Idaho fish and game commission,

1 or a person selected by that body. Each appointment made by the fish and game
 2 commission shall be for a term of three (3) years. One (1) member shall be
 3 selected from the public. Three (3) members of the board shall be qualified
 4 and licensed outfitters and guides who have not had less than five (5) years'
 5 experience in the business of outfitting and guiding in the state of Idaho.
 6 Each appointment shall be for the term of three (3) years and each board mem-
 7 ber shall hold office for a term of three (3) years. Upon the death, resig-
 8 nation or removal of any but the member representing the fish and game com-
 9 mission, the governor shall appoint a member to fill out the unexpired term
 10 as provided in this section. Immediately upon the creation of a vacancy, one
 11 (1) of the positions held by an outfitter or guide, either through expiration
 12 of term, death, resignation or removal, the Idaho outfitters and guides as-
 13 sociation shall submit to the governor the names of two (2) qualified persons
 14 for each such vacancy created and the appointment to fill such vacancy shall
 15 be made by the governor ~~from the names submitted within thirty (30) days af-~~
 16 ~~ter the receipt by the governor of the names submitted~~ who may consider rec-
 17 ommendations for appointment to the board from the association and from any
 18 individual residing in this state. All appointments to the board made after
 19 July 1, 1986, shall be subject to the advice and consent of the senate. Ap-
 20 pointments to fill any vacancy other than that created by the expiration of
 21 a term shall be made for the unexpired term. All board members shall serve
 22 at the pleasure of the governor. A majority of said board shall constitute a
 23 quorum. The board shall meet at least four (4) times a year, and at least two
 24 (2) meetings shall be held in Boise, Idaho. Each member of the board shall be
 25 compensated as provided by section 59-509(h), Idaho Code. The member repre-
 26 senting the fish and game commission shall be paid by the fish and game com-
 27 mission.

28 SECTION 2. That Section 54-203, Idaho Code, be, and the same is hereby
 29 amended to read as follows:

30 54-203. BOARD CREATED -- MEMBERSHIP -- APPOINTMENT -- VACAN-
 31 CIES. There is hereby created in the department of self-governing agencies a
 32 board of accountancy in and for the state of Idaho, to be known as the Idaho
 33 state board of accountancy. The board shall consist of seven (7) members,
 34 all of whom shall be residents of this state, appointed by the governor, five
 35 (5) of whom shall hold current certified public accountant licenses issued
 36 under the laws of this state, one (1) who shall be either a licensed public
 37 accountant or certified public accountant and one (1) public member not
 38 licensed under this chapter, who has professional or practical experience
 39 in the use of accounting services and financial statements. Board members
 40 shall be appointed for terms of five (5) years to commence on the first day
 41 of September and shall serve at the pleasure of the governor. ~~The existing~~
 42 ~~Board members of the Idaho state board of accountancy as previously ap-~~
 43 ~~pointed,~~ shall continue in office with their terms expiring on August 31 of
 44 each member's final year. Whenever the term for a member of the board ~~holding~~
 45 ~~one (1) of the seats on the board originally appointed from nominations of~~
 46 ~~the Idaho society of certified public accountants expires or becomes vacant~~
 47 ~~for any cause,~~ the governor may consider recommendations for appointment
 48 to the board from the Idaho society of certified public accountants shall
 49 ~~nominate two (2) persons with qualifications to become a member of the board~~

1 ~~as herein specified, for each such vacancy. Whenever the term for a member~~
 2 ~~holding the position on the board originally appointed from nominations of,~~
 3 ~~the Idaho association of public accountants expires or becomes vacant for~~
 4 ~~any cause, the Idaho association of public accountants shall nominate two~~
 5 ~~(2) persons with qualifications to become a member of the board as herein~~
 6 ~~specified, for each such vacancy. Nominations shall be forwarded to the gov-~~
 7 ~~ernor who shall appoint from such nominees the requisite number of persons~~
 8 ~~to be members of the board to fill such vacancy or vacancies. Whenever the~~
 9 ~~term for the public member on the board expires or becomes vacant for any~~
 10 ~~cause, the governor shall appoint a nonlicensed person to become a member~~
 11 ~~of the board without receiving official nominees from any source and from~~
 12 ~~any individual residing in this state. Vacancies occurring during the term~~
 13 ~~shall be filled by appointment by the governor for the unexpired term. Upon~~
 14 ~~expiration of the term of office, a member shall continue to serve until a~~
 15 ~~successor shall have been appointed and shall have qualified.~~

16 SECTION 3. That Section 54-312, Idaho Code, be, and the same is hereby
 17 amended to read as follows:

18 54-312. ARCHITECTS -- BOARD OF EXAMINERS -- POWERS AND DUTIES -- COM-
 19 PENSATION. (1) The board of architectural examiners is hereby created in the
 20 department of self-governing agencies. The board of architectural examiners
 21 shall consist of six (6) members, ~~to be appointed by the governor and to~~
 22 ~~serve at the pleasure of the governor, each five (5) of whom shall be ~~an~~ ar-~~
 23 ~~chitects, and shall have been a residents of and a lawfully practicing archi-~~
 24 ~~tects within the state of Idaho for a period of at least five (5) years next~~
 25 ~~before his appointment and one (1) of whom shall be a member of the public~~
 26 ~~with an interest in the rights of the consumers of architectural services.~~
 27 At all times the board shall have at least one (1) member who is engaged pri-
 28 marily in professional architectural education.

29 (2) The board shall have, in addition to the powers conferred elsewhere
 30 in this chapter, the following powers and duties:

31 (a) To authorize, by written agreement, the bureau of occupational li-
 32 censes to act as its agent in its interest.

33 (b) To adopt, pursuant to the administrative procedure act, such rules
 34 as the board, in its discretion, deems necessary for the administration
 35 and enforcement of this chapter.

36 (c) To conduct investigations into violations of this chapter.

37 (d) The board, or its duly appointed hearing officer, shall have the
 38 power in any disciplinary proceeding under this chapter, ~~to administer~~
 39 ~~oaths, take depositions of witnesses within or without the state in the~~
 40 ~~manner provided by law in civil cases, and may apply to any district~~
 41 ~~court of this state for a subpoena to require the attendance of such~~
 42 ~~witnesses and the production of such books, records, and papers as it~~
 43 ~~deems necessary. The fees and mileage of the witnesses shall be the~~
 44 ~~same as that allowed in the district courts in criminal cases, which~~
 45 ~~fees and mileage shall be paid in the same manner as other expenses of~~
 46 ~~the board are paid. In any case of disobedience to, or neglect of, any~~
 47 ~~subpoena or subpoena duces tecum served upon any person, or the refusal~~
 48 ~~of any witness to testify to any matter regarding which he may lawfully~~
 49 ~~be interrogated, it shall be the duty of any district court in this state~~

1 on application by the board to compel compliance with the subpoena by
 2 proceedings for contempt, as in the case of disobedience of the require-
 3 ments of a subpoena issued from such court or for refusal to testify
 4 therein. The licensed person accused in such proceedings shall have the
 5 same right of subpoena.

6 (e) To adopt rules requiring annual continuing education as a condition
 7 for the renewal of licenses issued under this chapter.

8 (3) Each member of the board of architectural examiners shall be com-
 9 pensated as provided by section 59-509(i), Idaho Code.

10 SECTION 4. That Section 54-313, Idaho Code, be, and the same is hereby
 11 amended to read as follows:

12 54-313. BOARD OF ARCHITECTURAL EXAMINERS -- CONTINUANCE OF PRESENT
 13 BOARD. The members of the board of architectural examiners in office at the
 14 date this act becomes effective shall continue in office until the expira-
 15 tion of their respective terms, subject to the provisions of this act.

16 The regular term of office of a member shall begin as of the first Monday
 17 immediately following the date of his appointment, and, for terms commenc-
 18 ing after February 1, 1971, shall continue for five (5) years thereafter and
 19 until his successor shall have been appointed and accepted such appointment.
 20 A member appointed to fill a vacancy occasioned otherwise than by expiration
 21 of a term shall serve the unexpired term of his predecessor. No members shall
 22 be appointed for a period exceeding two (2) consecutive terms. Any member
 23 who has served two (2) consecutive terms may be reappointed after a lapse of
 24 five (5) years from the termination date of his last term.

25 A vacancy in membership shall occur and be declared by the chief of the
 26 bureau of occupational licenses whenever the regular term of a member ex-
 27 pires or whenever a member dies, resigns, or is mentally or physically in-
 28 capable of acting, or neglects or refuses to act, or is removed or otherwise
 29 ceases to have the qualifications of a member.

30 SECTION 5. That Section 54-314, Idaho Code, be, and the same is hereby
 31 amended to read as follows:

32 54-314. FILLING VACANCIES ON BOARD. Prior to the expiration of the
 33 regular term of a member of or upon the occurrence or declaration of a vacancy
 34 in membership upon the board of architectural examiners, ~~the chief of the~~
 35 ~~bureau of occupational licenses shall in writing notify the officers of the~~
 36 ~~professional society thereof, and request said society, within sixty (60)-~~
 37 ~~days thereafter, to recommend three (3) architects with the qualifications~~
 38 ~~for membership for each appointment to be made to said board or for each~~
 39 ~~vacancy. Said recommended architects shall be selected by the officers or~~
 40 ~~members of said society in such manner as shall be determined by the society~~
 41 ~~and shall be certified by the secretary of the society to the governor within~~
 42 ~~such sixty (60) days. The governor shall appoint one (1) of the recommended~~
 43 ~~architects a qualified individual to fill the membership of or vacancy on~~
 44 ~~the board of architectural examiners; provided, however, that if no recom-~~
 45 ~~mendation be made within the time aforesaid, the governor may appoint any~~
 46 ~~architect qualified for membership and may consider recommendations for~~
 47 ~~appointment from any organization and from any individual residing in this~~

1 state. The governor shall notify the appointee of his appointment and the
2 appointee shall qualify by filing his acceptance with the governor.

3 SECTION 6. That Section 54-521, Idaho Code, be, and the same is hereby
4 amended to read as follows:

5 54-521. BOARD OF BARBER EXAMINERS -- POWERS AND DUTIES -- DESIGNATION
6 OF PERSONS TO REPORT TO BOARD. There is hereby created, and established in
7 the department of self-governing agencies, the board of barber examiners.
8 The board may, by written agreement, authorize the bureau of occupational
9 licenses as agent to act in the board's interest. In addition to the powers
10 otherwise conferred by this chapter, it shall be the duty of the board:

11 (1) To conduct or approve examinations to ascertain the qualifications
12 and fitness of applicants for licenses hereunder and to pass upon the quali-
13 fications of all applicants for licenses.

14 (2) To conduct hearings and proceedings in accordance with the provi-
15 sions of chapter 52, title 67, Idaho Code, to revoke licenses issued under
16 this chapter and to revoke such licenses subject to the provisions of this
17 chapter.

18 (3) To designate what schools of barbering within and without the state
19 are approved schools, and from time to time, to change such designations and
20 to keep public records thereof.

21 (4) To prescribe rules in accordance with the provisions of chapter 52,
22 title 67, Idaho Code, for a fair and wholly impartial method of examination
23 of applicants for licenses hereunder and, subject to the provisions of chap-
24 ter 52, title 67, Idaho Code, for conducting hearings for the revocation of
25 licenses, defining the qualifications of an approved school of barbering and
26 for the administration of this chapter in general.

27 Excepting the regulation of schools under section 54-507, Idaho Code,
28 ~~hereof~~, and the issuance of licenses under section 54-511, Idaho Code, none
29 of the powers and duties specified in subsections (1) through (4) of this
30 section, shall be exercised by the bureau except on the action of the board
31 of barber examiners. When vacancies occur on the board, the governor shall
32 appoint new members who shall serve at the pleasure of the governor, but not
33 more than a total of three (3) members, each two (2) of whom shall be a reg-
34 istered barbers, and shall have been a residents of, and lawfully practicing
35 barbering within the state of Idaho for a period of at least five (5) years
36 next before his their appointment, and who ~~is~~ are neither directly nor indi-
37 rectly in any way connected with or interested in the barber supply business
38 nor in any institution offering instruction in barbering and one (1) of whom
39 shall be a member of the public with an interest in the rights of consumers of
40 barber services. In appointing the members of the board the governor shall
41 give consideration to all nominations. The board and all assistants shall be
42 compensated as provided by section 59-509 (n), Idaho Code.

43 The regular term of office of a member of the board shall begin as of the
44 first Monday of July of the year in which he is appointed and shall continue
45 for three (3) years thereafter. A member appointed to fill a vacancy occa-
46 sioned otherwise than by expiration of a term shall serve the unexpired term
47 of his predecessor.

48 A vacancy in membership in the board shall occur, and be declared by the
49 governor, whenever the regular term of a member expires, or whenever a member

1 dies, resigns, or is found by the governor to be mentally or physically inca-
 2 pable of acting, or to be neglecting or refusing to act, or to cease to have
 3 the qualifications of a member, or to have acquired disqualifications of a
 4 member, or to have been absent without reasonable cause from two (2) succes-
 5 sive meetings of the board, or is removed.

6 The board of barber examiners shall select from its members a chairman
 7 and vice chairman who shall serve at the pleasure of the board.

8 The action and report in writing of the board so designated shall be suf-
 9 ficient authority upon which the bureau may act.

10 Whenever the board is satisfied that substantial justice has not been
 11 done, either in examination or in revocation of a license or otherwise, it
 12 may order a reexamination or rehearing of the matter.

13 SECTION 7. That Section 54-604, Idaho Code, be, and the same is hereby
 14 amended to read as follows:

15 54-604. ESTABLISHMENT OF STATE BOARD OF PODIATRY. (1) There is hereby
 16 established in the department of self-governing agencies a state board of
 17 podiatry to be composed of five (5) members to be appointed by the governor
 18 in the manner hereinafter set forth. Four (4) members shall be podiatrists,
 19 duly licensed under the laws of the state of Idaho, and who ~~shall~~ have been
 20 continuously engaged in the practice of podiatry for a period of not less

14 and paralegal, hearing officer and attorney's fees incurred by the

27 requirements for registration or licensure are at least substantially

29 (7) Exemptions.

30 (a) None of the provisions of this chapter shall prevent employees of
31 those lawfully practicing as landscape architects from acting under the
32 instruction, control or supervision of their employers.

33 (b) None of the provisions of this chapter shall apply to the business
34 conducted in this state by any land use planner, horticulturist, nurs-
35 eryman, or landscape nurseryman, gardener, landscape gardener, land-
36 scape designer, or landscape contractor, as these terms are generally
37 used, or any other person, including, but not limited to, their right to
38 plan and supervise in connection therewith, except that no such person

1 (b) Partners. Each partner in a partnership of landscape architects
2 shall be licensed to practice landscape architecture or to provide al-
3 lied professional services as defined in section 30-21-901, Idaho Code.
4 Subject to this requirement, a partnership of landscape architects may
5 use a partnership name if such name consists of:

6 (i) The names of two (2) or more landscape architects.

7 (ii) The names of one (1) or more landscape architects and one (1)
8 or more professional engineers or architects.

9 (c) Any person applying to the official of any county or city for a
10 business license to practice landscape architecture shall at the time
11 of such application exhibit to such official satisfactory evidence that
12 such applicant possesses a current Idaho license. The business license
13 shall not be granted until such evidence is presented, any contrary pro-
14 vision of any special act or general act notwithstanding.

15 (9) Qualifications for practice -- Seal:

16 (a) No person shall use the designation "landscape architect" or "land-
17 scape architecture" or advertise any title or description tending to
18 convey the impression that the person is a landscape architect, or
19 practicing landscape architecture, unless such person is a licensed
20 landscape architect. Every holder of a license shall display it in the
21 principal office, place of business or place of employment.

22 (b) Every landscape architect shall have a seal approved by the board,
23 which shall contain the name of the landscape architect and the words
24 "Licensed Landscape Architect, State of Idaho," and such other words or
25 figures as the board may deem necessary and prescribe.

26 (i) The seal may be a rubber stamp or an electronically applied
27 seal. Whenever the seal is applied, the licensee's written sig-
28 nature and the date shall be adjacent to or across the seal. The
29 seal, signature and date shall be placed on all final reports,
30 drawings and title pages of specifications, design information
31 and calculations. Whenever presented to a client or to the public,
32 such documents that are not final and do not contain a seal, signa-
33 ture and date, shall be clearly marked as "preliminary," "draft,"
34 "not for construction" or similar words to distinguish the docu-
35 ments from a finished product.

36 (ii) The application of the licensee's seal, signature and the
37 date shall constitute certification that the work thereon was pre-
38 pared by such landscape architect or under the supervision of such
39 landscape architect. Each plan or drawing sheet shall be sealed
40 and signed by the licensee or the licensee's agent responsible for
41 each sheet. The principal landscape architect in charge shall
42 sign and seal the title or first sheet. Copies of electronically
43 produced documents listed in paragraph (b) (i) of this subsection
44 that are distributed for informational use, such as for bidding
45 purposes or working copies, may be issued with the licensee's
46 seal and a notice that the original document is on file with the
47 licensee's signature and date. The words "original signed by:"

38 54-5309. IDAHO LIQUEFIED PETROLEUM GAS SAFETY BOARD. (1) There is
 39 hereby established in the department of self-governing agencies the Idaho
 40 liquefied petroleum gas safety board and the members thereof shall be ap-
 41 pointed by the governor. In making appointments, the governor shall give
 42 consideration to recommendations submitted by the rocky mountain propane
 43 association and other such nominations as may be received. If recommenda-
 44 tions are not made within sixty (60) days of notification and request, the
 45 governor may make appointments of any qualified individual from any individ-
 46 ual residing in this state.

47 (2) The board shall consist of five (5) members, two (2) of whom shall
 48 be licensed dealers pursuant to the provisions of this chapter; and one (1)
 49 of whom shall be a volunteer firefighter in a rural area of the state; and one

1 (1) of whom shall be a firefighter employed by a city fire department in the
 2 state; and one (1) of whom shall be a representative of the general public not
 3 employed or otherwise connected with the practices or operations regulated

5 (3) The members of the first board shall serve for the following terms:
 6 one (1) dealer member shall serve for one (1) year; one (1) firefighter mem-
 7 ber shall serve for two (2) years; one (1) dealer member shall serve for three
 8 (3) years; and one (1) firefighter member and the public member shall each
 9 serve for four (4) years. Each member shall serve from the effective date of
 10 appointment or until a successor is duly appointed and qualified. Upon the
 11 expiration of the term of any member of the board, the governor shall appoint
 12 the subsequent member for a term of four (4) years. No member shall be ap-
 13 pointed for more than two (2) successive terms.

14 (4) Board members shall serve at the pleasure of tThe governor ~~may re-~~
 15 ~~move any member of the board for misconduct, incompetence, neglect of duty,~~
 16 ~~or for any other cause.~~

17 (5) Three (3) members of the board shall constitute a quorum, and may
 18 exercise all the power and authority conferred on the board.

19 (6) ~~Within thirty (30) days of the appointment of the first board and~~
 20 ~~annually thereafter, t~~The members shall meet annually and elect from among
 21 the members by majority vote of those present a chairman who shall serve for
 22 one (1) year.

23 (7) The board shall meet ~~thereafter~~ no less than annually at such times
 24 and at such places as may be specified by the chairman or by the written re-
 25 quest of at least two (2) members.

26 (8) Each member of the board shall be compensated as provided in section
 27 59-509(n), Idaho Code.

28 SECTION 46. That Section 54-5606, Idaho Code, be, and the same is hereby
 29 amended to read as follows:

30 54-5606. BOARD -- ORGANIZATION AND MEETINGS. (1) There is hereby es-
 31 tablished in the department of self-governing agencies, bureau of occupa-
 32 tional licenses, the genetic counselors licensing board.

33 (2) The board shall consist of ~~three~~ four (34) members, two (2) of whom
 34 shall be fully licensed genetic counselors ~~and~~, one (1) of whom shall be a
 35 licensed physician and one (1) of whom shall be a member of the public with
 36 an interest in the rights of consumers of genetic counseling services. All
 37 board members shall be residents of this state.

38 (3) Initial appointments to the board shall be for the following terms:
 39 one (1) genetic counselor member shall serve a term of one (1) year; one (1)
 40 genetic counselor member shall serve a term of two (2) years; and the physi-
 41 cian member shall serve a term of three (3) years. Thereafter, the term of
 42 office for each member of the board shall be three (3) years.

43 (4) Board members shall be appointed by the governor and shall serve at
 44 the pleasure of the governor.

45 (5) Each genetic counselor member of the board shall:

46 (a) Except for the initial appointments, be currently licensed and in
 47 good standing to engage in the practice of genetic counseling in this
 48 state. The initial genetic counselor members of the board must meet the
 49 qualifications for licensure under this act;

1 (b) At the time of appointment have been actively engaged in the prac-
2 tice of genetic counseling for at least one (1) year of the last five (5)
3 years; and

4 (c) Be certified by the ABGC, ABMG or NSGC.

5 (6) In the event of the death, resignation or removal of any board mem-
6 ber before the expiration of the term to which the member is appointed, the
7 vacancy shall be filled for the unexpired portion of the term in the same man-
8 ner as the original appointment.

9 (7) The board shall meet annually and at such times as deemed neces-
10 sary and advisable by the chairman, or by a majority of its members, or by
11 the governor. Notice of all meetings shall be given in the manner prescribed
12 by rule. A majority of the board shall constitute a quorum at any meeting or
13 hearing.

14 (8) Members of the board shall be reimbursed for expenses as provided in
15 section 59-509(b), Idaho Code.

16 SECTION 47. SEVERABILITY. The provisions of this act are hereby de-
17 clared to be severable and if any provision of this act or the application
18 of such provision to any person or circumstance is declared invalid for any
19 reason, such declaration shall not affect the validity of the remaining por-
20 tions of this act.
