AN ACT

1 RELATING TO SEX CRIMES; AMENDING SECTION 18-6101, IDAHO CODE, TO REVISE TER-
2 MINOLOGY, TO PROVIDE A CIRCUMSTANCE WHERE RAPE CAN OCCUR AND TO PROVIDE
3 THAT BOTH MALES AND FEMALES ARE CAPABLE OF COMMITTING RAPE; AMENDING
4 SECTION 18-6107, IDAHO CODE, TO REVISE A CODE REFERENCE; REPEALING
5 SECTION 18-6108, IDAHO CODE, RELATING TO MALE RAPE; REPEALING SECTION
6 18-6109, IDAHO CODE, RELATING TO PUNISHMENT FOR MALE RAPE; AMENDING
7 SECTION 18-8304, IDAHO CODE, TO REMOVE OBSOLETE CODE REFERENCES AND
8 TO MAKE TECHNICAL CORRECTIONS; AMENDING SECTION 16-1602, IDAHO CODE,
9 TO REMOVE AN OBSOLETE CODE REFERENCE; AMENDING SECTION 16-2005, IDAHO

26 Be It Enacted by the Legislature of the State of Idaho:

27 SECTION 1. That Section 18-6101, Idaho Code, be, and the same is hereby
28 amended to read as follows:

29 18-6101. RAPE DEFINED. Rape is defined as the penetration, however
30 slight, of the oral, anal or vaginal opening with ~~the perpetrator's~~ a penis
31 accomplished ~~with a female~~ under any one (1) of the following circumstances:

32 (1) Where the ~~female~~ victim is under the age of sixteen (16) years and
33 the perpetrator is eighteen (18) years of age or older.

34 (2) Where the ~~female~~ victim is sixteen (16) or seventeen (17) years
35 of age and the perpetrator is three (3) years or more older than the ~~female~~
36 victim.

37 (3) Where ~~she~~ the victim is incapable, through any unsoundness of mind,
38 due to any cause including, but not limited to, mental illness, mental dis-
39 ability or developmental disability, whether temporary or permanent, of
40 giving legal consent.

41 (4) Where ~~she~~ the victim resists but ~~her~~ the resistance is overcome by
42 force or violence.

1 (5) Where ~~she~~ the victim is prevented from resistance by the infliction, attempted infliction, or threatened infliction of bodily harm, accompanied by apparent power of execution; or is unable to resist due to any intoxicating, narcotic, or anaesthetic substance.

5 (6) Where the victim is prevented from resistance due to an objectively reasonable belief that resistance would be futile or that resistance would result in force or violence beyond that necessary to accomplish the prohibited contact.

9 (7) Where ~~she~~ the victim is at the time unconscious of the nature of the act. As used in this section, "unconscious of the nature of the act" means incapable of resisting because the victim meets one (1) of the following conditions:

13 (a) Was unconscious or asleep;

14 (b) Was not aware, knowing, perceiving, or cognizant that the act occurred.

15
16 (78) Where ~~she~~ the victim submits under the belief that the person committing the act is ~~her husband~~ the victim's spouse, and the belief is induced by artifice, pretense or concealment practiced by the accused, with intent to induce such belief.

20 (89) Where ~~she~~ the victim submits under the belief that the person committing the act is someone other than the accused, and the belief is induced by artifice, pretense or concealment practiced by the accused, with the intent to induce such belief.

24 (910) Where ~~she~~ the victim submits under the belief, instilled by the actor, that if ~~she~~ the victim does not submit, the actor will cause physical harm to some person in the future; or cause damage to property; or engage in other conduct constituting a crime; or accuse any person of a crime or cause criminal charges to be instituted against ~~her~~ the victim; or expose a secret or publicize an asserted fact, whether true or false, tending to subject any person to hatred, contempt or ridicule.

31 The provisions of subsections (1) and (2) of this section shall not affect the age requirements in any other provision of law, unless otherwise provided in any such law. Further, for the purposes of subsection (2) of this section, in determining whether the perpetrator is three (3) years or more older than the ~~female~~ victim, the difference in age shall be measured from the date of birth of the perpetrator to the date of birth of the ~~female~~ victim.

38 Males and females are both capable of committing the crime of rape as defined in this section.

40 SECTION 2. That Section 18-6107, Idaho Code, be, and the same is hereby amended to read as follows:

42 18-6107. RAPE OF SPOUSE. No person shall be convicted of rape for any act or acts with that person's spouse, except under the circumstances cited in subsections (4) ~~and~~, (5), (6) and (10) of section 18-6101, Idaho Code.

45 SECTION 3. That Section [18-6108](#), Idaho Code, be, and the same is hereby repealed.

1 SECTION 4. That Section [18-6109](#), Idaho Code, be, and the same is hereby
2 repealed.

3 SECTION 5. That Section 18-8304, Idaho Code, be, and the same is hereby
4 amended to read as follows:

5 18-8304. APPLICATION OF CHAPTER -- RULEMAKING AUTHORITY. (1) The pro-
6 visions of this chapter shall apply to any person who:

7 (a) On or after July 1, 1993, is convicted of the crime, or an at-
8 tempt, a solicitation, or a conspiracy to commit a crime provided for
9 in section 18-909 (assault with intent to commit rape, infamous crime
10 against nature, or lewd and lascivious conduct with a minor, but exclud-
11 ing mayhem, murder or robbery), 18-911 (battery with intent to commit
12 rape, infamous crime against nature, or lewd and lascivious conduct
13 with a minor, but excluding mayhem, murder or robbery), 18-919 (sexual
14 exploitation by a medical care provider), 18-1505B (sexual abuse and
15 exploitation of a vulnerable adult), 18-1506 (sexual abuse of a child
16 under sixteen years of age), 18-1506A (ritualized abuse of a child),
17 18-1507 (sexual exploitation of a child), 18-1508 (lewd conduct with
18 a minor child), 18-1508A (sexual battery of a minor child sixteen or
19 seventeen years of age), 18-1509A (enticing a child over the inter-
20 net), 18-4003(d) (murder committed in perpetration of rape), 18-4116
21 (indecent exposure, but excluding a misdemeanor conviction), 18-4502
22 (first degree kidnapping committed for the purpose of rape, committing
23 the infamous crime against nature or for committing any lewd and las-
24 civious act upon any child under the age of sixteen, or for purposes of
25 sexual gratification or arousal), 18-4503 (second degree kidnapping
26 where the victim is an unrelated minor child), 18-5605 (detention for
27 prostitution), 18-5609 (inducing person under eighteen years of age
28 into prostitution), 18-5610 (utilizing a person under eighteen years of
29 age for prostitution), 18-5611 (inducing person under eighteen years of
30 age to patronize a prostitute), 18-6101 (rape, but excluding 18-6101(1)
31 where the defendant is eighteen years of age), ~~18-6108 (male rape, but~~
32 ~~excluding 18-6108(1) where the defendant is eighteen years of age),~~
33 18-6110 (sexual contact with a prisoner), 18-6602 (incest), 18-6605
34 (crime against nature), 18-6608 (forcible sexual penetration by use of
35 a foreign object), 18-6609 (video voyeurism where the victim is a minor
36 or upon a second or subsequent conviction), 18-7804 (if the racketeer-
37 ing act involves kidnapping of a minor) or 18-8602(1), Idaho Code, (sex
38 trafficking).

39 (b) On or after July 1, 1993, has been convicted of any crime, an
40 attempt, a solicitation or a conspiracy to commit a crime in another ju-
41 risdiction or who has a foreign conviction that is substantially equiv-
42 alent to the offenses listed in ~~subsection (1)~~ paragraph (a) of this
43 subsection and enters this state to establish residence or for employ-
44 ment purposes or to attend, on a full-time or part-time basis, any pub-
45 lic or private educational institution including any secondary school,
46 trade or professional institution or institution of higher education.

47 (c) Has been convicted of any crime, an attempt, a solicitation or a
48 conspiracy to commit a crime in another jurisdiction, including mili-
49 tary courts, that is substantially equivalent to the offenses listed in

1 ~~subsection (1) paragraph~~ (a) of this subsection and was required to reg-
 2 ister as a sex offender in any other state or jurisdiction when he estab-
 3 lished residency in Idaho.

4 (d) Pleads guilty to or has been found guilty of a crime covered in this
 5 chapter prior to July 1, 1993, and the person, as a result of the of-
 6 fense, is incarcerated in a county jail facility or a penal facility or
 7 is under probation or parole supervision, on or after July 1, 1993.

8 (e) Is a nonresident regularly employed or working in Idaho or is a stu-
 9 dent in the state of Idaho and was convicted, found guilty or pleaded
 10 guilty to a crime covered by this chapter and, as a result of such con-
 11 viction, finding or plea, is required to register in his state of resi-
 12 dence.

13 (2) An offender shall not be required to comply with the registration
 14 provisions of this chapter while incarcerated in a correctional institution
 15 of the department of correction, a county jail facility, committed to the de-
 16 partment of juvenile corrections or committed to a mental health institution
 17 of the department of health and welfare.

18 (3) A conviction for purposes of this chapter means that the person has
 19 pled guilty or has been found guilty, notwithstanding the form of the judg-
 20 ment or withheld judgment.

21 (4) The department shall have authority to promulgate rules to imple-
 22 ment the provisions of this chapter.

23 SECTION 6. That Section 16-1602, Idaho Code, be, and the same is hereby
 24 amended to read as follows:

25 16-1602. DEFINITIONS. For purposes of this chapter:

26 (1) "Abused" means any case in which a child has been the victim of:

27 (a) Conduct or omission resulting in skin bruising, bleeding, malnu-
 28 trition, burns, fracture of any bone, subdural hematoma, soft tissue
 29 swelling, failure to thrive or death, and such condition or death is not
 30 justifiably explained, or where the history given concerning such con-
 31 dition or death is at variance with the degree or type of such condition
 32 or death, or the circumstances indicate that such condition or death may
 33 not be the product of an accidental occurrence; or

34 (b) Sexual conduct, including rape, molestation, incest, prostitu-
 35 tion, obscene or pornographic photographing, filming or depiction for
 36 commercial purposes, or other similar forms of sexual exploitation
 37 harming or threatening the child's health or welfare or mental injury to
 38 the child.

39 (2) "Abandoned" means the failure of the parent to maintain a normal
 40 parental relationship with his child including, but not limited to, reason-
 41 able support or regular personal contact. Failure to maintain this rela-
 42 tionship without just cause for a period of one (1) year shall constitute
 43 prima facie evidence of abandonment.

44 (3) "Adaptive equipment" means any piece of equipment or any item that
 45 is used to increase, maintain or improve the parenting capabilities of a par-
 46 ent with a disability.

47 (4) "Adjudicatory hearing" means a hearing to determine:

48 (a) Whether the child comes under the jurisdiction of the court pur-
 49 suant to the provisions of this chapter;

1 (b) Whether continuation of the child in the home would be contrary to
2 the child's welfare and whether the best interest of the child requires
3 protective supervision or vesting legal custody of the child in an au-
4 thorized agency.

5 (5) "Aggravated circumstances" includes, but is not limited to:

6 (a) Circumstances in which the parent has engaged in any of the follow-
7 ing:

8 (i) Abandonment, chronic abuse or chronic neglect of the child.
9 Chronic neglect or chronic abuse of a child shall consist of abuse
10 or neglect that is so extreme or repetitious as to indicate that
11 return of the child to the home would result in unacceptable risk
12 to the health and welfare of the child.

13 (ii) Sexual abuse against a child of the parent. Sexual abuse, for
14 the purposes of this section, includes any conduct described in
15 section 18-1506, 18-1506A, 18-1507, 18-1508, 18-1508A, 18-6101,
16 ~~18-6108~~ or 18-6608, Idaho Code.

17 (iii) Torture of a child; any conduct described in the code sec-
18 tions listed in section 18-8303(1), Idaho Code; battery or an
19 injury to a child that results in serious or great bodily in-
20 jury to a child; voluntary manslaughter of a child, or aiding or
21 abetting such voluntary manslaughter, soliciting such voluntary
22 manslaughter or attempting or conspiring to commit such voluntary
23 manslaughter;

24 (b) The parent has committed murder, aided or abetted a murder, so-
25 licited a murder or attempted or conspired to commit murder; or

26 (c) The parental rights of the parent to another child have been termi-
27 nated involuntarily.

28 (6) "Authorized agency" means the department, a local agency, a person,
29 an organization, corporation, benevolent society or association licensed
30 or approved by the department or the court to receive children for control,
31 care, maintenance or placement.

32 (7) "Case plan hearing" means a hearing to approve, modify or reject the
33 case plan as provided in section 16-1621, Idaho Code.

34 (8) "Child" means an individual who is under the age of eighteen (18)
35 years.

36 (9) "Child advocacy center" or "CAC" means an organization that adheres
37 to national best practice standards established by the national membership
38 and accrediting body for children's advocacy centers and that promotes a
39 comprehensive and coordinated multidisciplinary team response to alle-
40 gations of child abuse by maintaining a child-friendly facility at which
41 appropriate services are provided. These services may include forensic in-
42 terviews, forensic medical examinations, mental health services and other
43 related victim services.

44 (10) "Circumstances of the child" includes, but is not limited to, the
45 joint legal custody or joint physical custody of the child.

46 (11) "Commit" means to transfer legal and physical custody.

47 (12) "Concurrent planning" means a planning model that prepares for and
48 implements different outcomes at the same time.

49 (13) "Court" means district court or magistrate's division thereof, or
50 if the context requires, a magistrate or judge thereof.

1 (14) "Custodian" means a person, other than a parent or legal guardian,
2 to whom legal or joint legal custody of the child has been given by court or-
3 der.

4 (15) "Department" means the department of health and welfare and its au-
5 thorized representatives.

6 (16) "Disability" means, with respect to an individual, any mental or
7 physical impairment which substantially limits one (1) or more major life
8 activity of the individual including, but not limited to, self-care, man-
9 ual tasks, walking, seeing, hearing, speaking, learning or working, or a
10 record of such an impairment, or being regarded as having such an impairment.
11 Disability shall not include transvestism, transsexualism, pedophilia,
12 exhibitionism, voyeurism, other sexual behavior disorders, or substance use
13 disorders, compulsive gambling, kleptomania or pyromania. Sexual prefer-
14 ence or orientation is not considered an impairment or disability. Whether
15 an impairment substantially limits a major life activity shall be determined
16 without consideration of the effect of corrective or mitigating measures
17 used to reduce the effects of the impairment.

18 (17) "Family or household member" shall have the same meaning as in sec-
19 tion 39-6303(6), Idaho Code.

20 (18) "Foster care" means twenty-four (24) hour substitute parental care
21 for children placed away from their parents or guardians by persons who may
22 or may not be related to the children and for whom the state agency has place-
23 ment and care responsibility.

24 (19) "Grant administrator" means the supreme court or any organization
25 or agency as may be designated by the supreme court in accordance with such
26 procedures as may be adopted by the supreme court. The grant administrator
27 shall administer funds from the guardian ad litem account in accordance with
28 the provisions of this chapter.

29 (20) "Guardian ad litem" means a person appointed by the court pursuant
30 to a guardian ad litem volunteer program to act as special advocate for a
31 child under this chapter.

32 (21) "Guardian ad litem coordinator" means a person or entity receiving
33 moneys from the grant administrator for the purpose of carrying out any of
34 the duties set forth in section 16-1632, Idaho Code.

35 (22) "Guardian ad litem program" means the program to recruit, train and
36 coordinate volunteer persons to serve as guardians ad litem for abused, ne-
37 glected or abandoned children.

38 (23) "Homeless," as used in this chapter, shall mean that the child is
39 without adequate shelter or other living facilities, and the lack of such
40 shelter or other living facilities poses a threat to the health, safety or
41 well-being of the child.

42 (24) "Idaho network of children's advocacy centers" means an organiza-
43 tion that provides education and technical assistance to child advocacy cen-
44 ters and to interagency multidisciplinary teams developed pursuant to sec-
45 tion 16-1617, Idaho Code.

46 (25) "Law enforcement agency" means a city police department, the pros-
47 ecuting attorney of any county, state law enforcement officers, or the of-
48 fice of a sheriff of any county.

49 (26) "Legal custody" means a relationship created by court order, which
50 vests in a custodian the following rights and responsibilities:

1 (a) To have physical custody and control of the child, and to determine
2 where and with whom the child shall live.

3 (b) To supply the child with food, clothing, shelter and incidental ne-
4 cessities.

5 (c) To provide the child with care, education and discipline.

6 (d) To authorize ordinary medical, dental, psychiatric, psychologi-
7 cal, or other remedial care and treatment for the child, including care
8 and treatment in a facility with a program of services for children; and
9 to authorize surgery if the surgery is deemed by two (2) physicians li-
10 censed to practice in this state to be necessary for the child.

11 (e) Where the parents share legal custody, the custodian may be vested
12 with the custody previously held by either or both parents.

13 (27) "Mental injury" means a substantial impairment in the intellectual
14 or psychological ability of a child to function within a normal range of per-
15 formance and/or behavior, for short or long terms.

16 (28) "Neglected" means a child:

17 (a) Who is without proper parental care and control, or subsistence,
18 medical or other care or control necessary for his well-being because of
19 the conduct or omission of his parents, guardian or other custodian or
20 their neglect or refusal to provide them; however, no child whose parent
21 or guardian chooses for such child treatment by prayers through spiri-
22 tual means alone in lieu of medical treatment shall be deemed for that
23 reason alone to be neglected or lack parental care necessary for his
24 health and well-being, but this subsection shall not prevent the court
25 from acting pursuant to section 16-1627, Idaho Code; or

26 (b) Whose parents, guardian or other custodian are unable to discharge
27 their responsibilities to and for the child and, as a result of such
28 inability, the child lacks the parental care necessary for his health,
29 safety or well-being; or

30 (c) Who has been placed for care or adoption in violation of law; or

31 (d) Who is without proper education because of the failure to comply
32 with section 33-202, Idaho Code.

33 (29) "Permanency hearing" means a hearing to review, approve, reject or
34 modify the permanency plan of the department, and review reasonable efforts
35 in accomplishing the permanency plan.

36 (30) "Permanency plan" means a plan for a continuous residence and main-
37 tenance of nurturing relationships during the child's minority.

38 (31) "Protective order" means an order issued by the court in a child
39 protection case, prior to the adjudicatory hearing, to enable the child to
40 remain in the home pursuant to section 16-1615(5)(f), Idaho Code. Such an
41 order shall be in the same form and have the same effect as a domestic vio-
42 lence protection order issued pursuant to chapter 63, title 39, Idaho Code.
43 A protective order shall be for a period not to exceed three (3) months unless
44 otherwise stated in the order.

45 (32) "Protective supervision" is a legal status created by court order
46 in a child protective case whereby the child is in the legal custody of his or
47 her parent(s), guardian(s) or other legal custodian(s), subject to supervi-
48 sion by the department.

1 (33) "Relative" means a child's grandparent, great grandparent, aunt,
2 great aunt, uncle, great uncle, brother-in-law, sister-in-law, first
3 cousin, sibling and half-sibling.

4 (34) "Residual parental rights and responsibilities" means those
5 rights and responsibilities remaining with the parents after the transfer of
6 legal custody including, but not necessarily limited to, the right of visi-
7 tation, the right to consent to adoption, the right to determine religious
8 affiliation, the right to family counseling when beneficial, and the respon-
9 sibility for support.

10 (35) "Shelter care" means places designated by the department for tem-
11 porary care of children pending court disposition or placement.

12 (36) "Supportive services," as used in this chapter, shall mean ser-
13 vices which assist parents with a disability to compensate for those aspects
14 of their disability which affect their ability to care for their child and
15 which will enable them to discharge their parental responsibilities. The
16 term includes specialized or adapted training, evaluations or assistance
17 with effectively using adaptive equipment and accommodations which allow
18 parents with a disability to benefit from other services including, but not
19 limited to, Braille texts or sign language interpreters.

20 SECTION 7. That Section 16-2005, Idaho Code, be, and the same is hereby
21 amended to read as follows:

22 16-2005. CONDITIONS UNDER WHICH TERMINATION MAY BE GRANTED. (1) The
23 court may grant an order terminating the relationship where it finds that
24 termination of parental rights is in the best interests of the child and that
25 one (1) or more of the following conditions exist:

26 (a) The parent has abandoned the child.

27 (b) The parent has neglected or abused the child.

28 (c) The presumptive parent is not the biological parent of the child.

29 (d) The parent is unable to discharge parental responsibilities and
30 such inability will continue for a prolonged indeterminate period and
31 will be injurious to the health, morals or well-being of the child.

32 (e) The parent has been incarcerated and is likely to remain incarcer-
33 ated for a substantial period of time during the child's minority.

34 (2) The court may grant an order terminating the relationship and may
35 rebuttably presume that such termination of parental rights is in the best
36 interests of the child where:

37 (a) The parent caused the child to be conceived as a result of rape,
38 incest, lewd conduct with a minor child under the age of sixteen (16)
39 years, or sexual abuse of a child under the age of sixteen (16) years, as
40 defined in sections 18-6101, 18-1508, 18-1506 and 18-6602, Idaho Code;

41 (b) The following circumstances are present:

42 (i) Abandonment, chronic abuse or chronic neglect of the child.
43 Chronic neglect or chronic abuse of a child shall consist of abuse
44 or neglect that is so extreme or repetitious as to indicate con-
45 tinuing the relationship would result in unacceptable risk to the
46 health and welfare of the child;

47 (ii) Sexual abuse against a child of the parent. Sexual abuse, for
48 the purposes of this section, includes any conduct described in

1 section 18-1506, 18-1506A, 18-1507, 18-1508, 18-1508A, 18-6101,
2 ~~18-6108~~ or 18-6608, Idaho Code;

3 (iii) Torture of a child; any conduct described in the code sec-
4 tions listed in section 18-8303(1), Idaho Code; battery or an
5 injury to a child that results in serious or great bodily in-
6 jury to a child; voluntary manslaughter of a child, or aiding or
7 abetting such voluntary manslaughter, soliciting such voluntary
8 manslaughter or attempting or conspiring to commit such voluntary
9 manslaughter;

10 (iv) The parent has committed murder, aided or abetted a murder,
11 solicited a murder or attempted or conspired to commit murder; or

12 (c) The court determines the child to be an abandoned infant, except in
13 a parental termination action brought by one (1) parent against another
14 parent.

15 (3) The court may grant an order terminating the relationship if termi-
16 nation is found to be in the best interest of the parent and child.

17 (4) The court may grant an order terminating the relationship where a
18 consent to termination in the manner and form prescribed by this chapter has
19 been filed by the parent(s) of the child in conjunction with a petition for
20 adoption initiated by the person or persons proposing to adopt the child,
21 or where the consent to termination has been filed by a licensed adoption
22 agency, no subsequent hearing on the merits of the petition shall be held.

1 shall be charged, arrested and proceeded against by complaint, indictment
2 or information as an adult. All other felonies or misdemeanors charged in
3 the complaint, indictment or information, which are based on the same act
4 or transaction or on one (1) or more acts or transactions as the violent
5 or controlled substances offense shall similarly be charged, arrested and
6 proceeded against as an adult. Any juvenile proceeded against pursuant to
7 this section shall be accorded all constitutional rights, including bail and
8 trial by jury, and procedural safeguards as if that juvenile were an adult

10 (2) Once a juvenile has been formally charged or indicted pursuant to
11 this section or has been transferred for criminal prosecution as an adult
