APPROPRIATING MONEYS TO THE DEPARTMENT OF FISH AND GAME FOR FISCAL YEAR 2017;
AND LIMITING THE NUMBER OF AUTHORIZED FULL-TIME EQUIVALENT POSITIONS.

Be It Enacted by the Legislature of the State of Idaho:

SECTION 1. There is hereby appropriated to the Department of Fish and Game, the following amounts to be expended according to the designated programs and expense classes, from the listed funds for the period July 1, 2016, through June 30, 2017:

21 SECTION 2. FTP AUTHORIZATION. In accordance with Section 67-3519,
22 Idaho Code, the Department of Fish and Game is authorized no more than five
23 hundred fifty-eight (558) full-time equivalent positions at any point dur-
24 ing the period July 1, 2016, through June 30, 2017, unless specifically
25 authorized by the Governor. The Joint Finance-Appropriations Committee
26 will be notified promptly of any increased positions so authorized.
