RS 24059: **Rep. Redman** presented **RS 24059**. The proposed legislation is written to be the public policy of the State of Idaho to protect its citizens from the application of foreign laws when the application of foreign law will result in the violation of a fundamental right guaranteed by the Constitution of the United States or the Constitution of the State of Idaho including, but not limited to, due process, freedom of religion, speech or press and any right of privacy or marriage embodied in the Constitution.

MOTION: **Rep. Crane** made a motion to introduce **RS 24059**.

The proposed amendment adds to Idaho Code to allow for the dissolution of a Watershed Improvement District that fails or has ceased to function for two or more years. The county commissioners may initiate such action on their own volition, or it can be initiated by petition.

MOTION: **Rep. Moyle** made a motion to introduce **RS 24643. Motion carried by voice vote.**

Chairman Perry called the meeting to order at 12:09 P.M.

MOTION: **Rep. Crane** made a motion to approve the minutes of the March 22, 2016 meeting.
Motion carried by voice vote.

RS 24808: **Rep. Dixon** presented **RS 24808**. The proposed legislation brings breweries into alignment with wineries by allowing minors in tasting rooms. Current code allows them to enter a winery tasting room but does not account for breweries. Craft brewing is a new and growing industry in our state, and many of those breweries offer tours and tastings as a part of their business. Like wineries that offer tours, craft brewery tours and tasting rooms are an experience meant to focus on the craftsmanship of the brewers.

In answer to committee questions, **Rep. Dixon** deferred to **Jeremy Pisca**, representing Idaho Beer & Wine Distributors Association. Mr. Pisca stated Beer and wine products are sold through a three-tier system. That system creates financial separation between the manufacturer/brewer, distributor and retailer. There is a small brewer exception to the three-tier system. If a brewer brews less than 30,000 barrels annually, the brewer can occupy all three tiers. The Idaho Beer and Wine Distributors association is currently engaged in litigation to clarify how 30,000 barrels is calculated. Specifically at issue is whether it matters where such beer is produced. **HB 597** was amended in the Senate to include a definition that unintentionally may have impacted that pending litigation. **RS 24808** modifies that definition so the bill has no effect on the lawsuit currently pending.

MOTION: **Rep. Moyle** made a motion to introduce **RS 24808**.

Rep. Erpelding asked for clarification. He asked if the RS should be sent to the Second Reading Calendar.

Rep. Moyle responded the Speaker would make that determination.
