

Recruitment

Programs recruit volunteers within the communities children live.

All volunteers must complete the following every two years

- NCIC background check
- DHW Child Abuse Central Registry
- Idaho's Sex Offender Registry

Training

All volunteers complete at least 30 hours of pre-service training, topics include:

- Roles and Responsibilities of a GAL/CASA volunteer
- Court Process
- Dynamics of Families including mental health, substance abuse, domestic violence and poverty
- Relevant state laws, regulations and policies
- Relevant federal laws, regulations and policies
- Confidentiality and record keeping practices
- Child Development Child abuse and neglect
- Permanency Planning
- Community agencies and resources
- Communication and information gathering
- Effective advocacy
- Cultural Competency
- Special Needs of the children served

Court Appointed Special Advo

Retention

- Provide a minimum 12 hours of in-service training per year
- Through supervision we provide support to volunteer advocates as they navigate through a complex system
- Develop and support recognition activities to acknowledge the commitment and dedication of our volunteer GAL/CASA advocates

GAL/CASA Duties

Investigate

Carry out an objective examination of the situation, including relevant history, environment, relationships and needs of the child

Court Appointed Special Advo

GAL/CASA Duties

Advocate

Speak up for the child by making recommendations regarding the child's best interests in a written court report.

Court Appointed Special Advo

GAL/CASA Duties

Facilitate

Identify resources and services for the child and facilitate a collaborative relationship between all parties involved in the case, helping to create a situation in which the child's needs can be met

Court Appointed Special Advo

GAL/CASA Duties

Monitor

Monitor the circumstances of the child and ensure court ordered services are fulfilled and continue to be in the child's best interest.
