AN ACT

1 APPROPRIATING ADDITIONAL MONEYS TO THE EXECUTIVE OFFICE OF THE GOVERNOR FOR
2 FISCAL YEAR 2017; AUTHORIZING AN ADDITIONAL FULL-TIME EQUIVALENT POSI-
3 TION FOR FISCAL YEAR 2017; APPROPRIATING ADDITIONAL MONEYS TO THE EXEC-
4 UTIVE OFFICE OF THE GOVERNOR FOR FISCAL YEAR 2018; AUTHORIZING AN ADDI-
5 TIONAL FULL-TIME EQUIVALENT POSITION FOR FISCAL YEAR 2018; AND DECLAR-
6 ING AN EMERGENCY.

8 Be It Enacted by the Legislature of the State of Idaho:

9 SECTION 1. In addition to the appropriation made in Section 1, Chap-
10 ter 301, Laws of 2016, and any other appropriation provided for by law, there
11 is hereby appropriated from the General Fund to the Executive Office of the
12 Governor, for the administrator of invasive species policy, the following
13 amounts to be expended for the designated expense classes, for the period
14 July 1, 2016, through June 30, 2017:

17 Operating Expenditures	7,200
18 Capital Outlay	<u>5,000</u>

20 SECTION 2. FTP AUTHORIZATION. The full-time equivalent position autho-
21 rization provided to the Executive Office of the Governor in Section 2, Chap-
22 ter 301, Laws of 2016, is increased by one (1) for the period July 1, 2016,
23 through June 30, 2017.

24 SECTION 3. In addition to the appropriation made in Section 1 of House
25 Bill No. 280, as enacted by the First Regular Session of the Sixty-fourth
26 Idaho Legislature, there is hereby appropriated to the Executive Office of
27 the Governor, for the administrator of invasive species policy, the follow-
28 ing amounts to be expended according to the designated expense classes from
29 the General Fund for the period July 1, 2017, through June 30, 2018:

34 SECTION 4. FTP AUTHORIZATION. The full-time equivalent position au-
35 thorization provided to the Executive Office of the Governor in Section
36 2 of House Bill No. 280, as enacted by the First Regular Session of the

1 Sixty-fourth Idaho Legislature, is increased by one (1) for the period July
2 1, 2017, through June 30, 2018.

3 SECTION 5. An emergency existing therefor, which emergency is hereby
4 declared to exist, the provisions of Sections 1 and 2 of this act shall be in
5 full force and effect on and after passage and approval.
