Chairman VanOrden called the meeting to order at 9:01 am.

RS 24870: **Blake Youde**, ID State Board of Education, presented **RS 24870** relating to teacher preparation programs that measure teaching skills congruent with current research on reading practices.

MOTION: **Rep. Amador** made a motion to introduce **RS 24870**. **Motion carried by voice vote.**

RS 24897: **Blake Youde** presented **RS 24897** relating to residential schools making reports to the Department of Education.

MOTION: **Rep. Kloc** made a motion to introduce **RS 24897**. **Motion carried by voice vote.**

RS 24906: **Blake Youde** presented **RS 24906** relating to the interstate compact for western regional cooperation in higher education with regards to Hawaii and Alaska recognized as states, not territories.

MOTION: **Rep. McCrostie** made a motion to introduce **RS 24906**. **Motion carried by voice vote.**

RS 25080: **Jason Kreizenbeck**, Lobby Idaho, LLC, presented **RS 25080** relating to the instruction or practice of yoga on behalf of their client, Yoga Alliance. **RS 25080** will add yoga to the list of individuals and entities that are specifically exempt from the registration requirements of propriety schools.

MOTION: **Rep. Cheatham** made a motion to introduce **RS 25080**. **Motion carried by voice vote.**

Rep. Clow presented his subcommittee recommendations review of the Administrative Rules assigned from the State Board of Education and the Department of Education. The subcommittee recommends all dockets be approved including the notice of correction to pending rule, **Docket No. 08-0202-1607**, by the full committee. **Tracie Bent**, State Board of Education clarified the correction of **Docket No. 08-0202-1607**.

MOTION: **Rep. Clow** made a motion to accept the report of the Clow Subcommittee. **Motion carried by voice vote.**

Rep. McDonald presented his subcommittee recommendations review of the Administrative Rules assigned from the State Board of Education and the Department of Education. The subcommittee recommends all dockets be approved, with the exception of **Docket No. 08-0203-1601**, which the subcommittee recommends it be referred back to the full committee without recommendation for further discussion.

MOTION: **Rep. McDonald** made a motion to accept the report of the McDonald Subcommittee. **Motion carried by voice vote.**

Rep. Kerby presented his subcommittee recommendations review of the Administrative Rules assigned from the State Board of Education and the Department of Education. The subcommittee recommends all dockets be approved with the exception of **Docket No. 08-0202-1605**, which the subcommittee recommends it be rejected. **Tracie Bent** clarified the rejection procedure of **Docket No. 08-0202-1605**.

MOTION: **Rep. Kerby** made the motion to accept the report of the Kerby Subcommittee. **Chairman VanOrden** recommended another review of **Docket No. 08-0202-1605** in full committee on February 3, 2017.
