According to DHW:

In direct T&B appropriation, DHW gets \$5.6 million for felony Probation and Parole services. Additionally, DHW is the sole provider of mental health services to all mental health courts in Idaho. All of these MH court participants are on felony probation. DHW receives personnel and operating funds for the delivery of services to this population, but it is difficult to know the exact amount as staff also work in other programs within the adult mental health program. The closest estimate I have is roughly \$1.9 million in resources to serve the mental health court population. Additionally, we serve patients in our clinic and crisis programs that we know are involved with IDOC, but there is not tracking mechanisms to even estimate those service costs.

Currently, we have used roughly \$600,000 of the \$5.6 million for probation and parole services. The model we have for service delivery is a smart model, but the buildup and rollout is taking much longer than I assumed it would. We contract with the network of Federally Qualified Health Centers (FQHCs) across Idaho. This is good because it provides not only mental health care to the participants, but also they have the ability to meet the primary care and oral health needs. The other benefit of using the FQHCs is they have access to steeply discounted medication, which is and will be a large part of the expense for this population.
