Pursuant to Section 67-454, Idaho Code, a meeting on the enclosed rules may be called by the
cochairmen or by two (2) or more members of the subcommittee giving oral or written notice to Research
and Legislation no later than fourteen (14) days after receipt of the rules' analysis from Legislative
Services. The final date to call a meeting on the enclosed rules is no later than 09/24/2018. If a meeting is
called, the subcommittee must hold the meeting within forty-two (42) days of receipt of the rules' analysis
from Legislative Services. The final date to hold a meeting on the enclosed rules is 10/23/2018.

The germane joint subcommittee may request a statement of economic impact with respect to a
proposed rule by notifying Research and Legislation. There is no time limit on requesting this statement,
and it may be requested whether or not a meeting on the proposed rule is called or after a meeting has
been held.

Summary and Stated Reasons for the Proclamation

The Idaho Department of Fish and Game submits notice of [Amended] Amended Proclamation adopting adjustments to the 2018 season for hunting gray wolf and the 2018-2019 season for trapping gray wolf, as previously adopted by proclamation for 2017-2018 Big Game Seasons. The department notes that the amendments extend hunting seasons for gray wolf in all or portions of multiple Game Management Units; expand the trapping area for gray wolf in Game Management Unit 2; extend or open trapping seasons for foothold traps only in all or portions of Game Management Units 4, 4A, 32A, 33, 39 (Boise and Elmore Counties only), 43, 44, 66 and 69; and allow snares on private lands during part of the trapping seasons in Game Management Units 32A, 33, 66 and 69.
