AN ACT

1 RELATING TO THE STATE CONTROLLER; AMENDING CHAPTER 10, TITLE 67, IDAHO CODE,
2 BY THE ADDITION OF A NEW SECTION 67-1021A, IDAHO CODE, TO AUTHORIZE THE
3 STATE CONTROLLER TO ENGAGE IN A PROJECT TO MODERNIZE AND REPLACE THE
4 STATE'S BUSINESS INFORMATION INFRASTRUCTURE AND TO PROVIDE FOR FUND-
5 ING; AMENDING CHAPTER 10, TITLE 67, IDAHO CODE, BY THE ADDITION OF A
6 NEW SECTION 67-1021B, IDAHO CODE, TO CREATE THE LEADERSHIP COUNCIL FOR
7 THE BUSINESS INFORMATION INFRASTRUCTURE PROGRAM AND TO AUTHORIZE THE
8 CREATION OF WORKING COMMITTEES OR ADVISORY BOARDS; AMENDING CHAPTER 10,
9 TITLE 67, IDAHO CODE, BY THE ADDITION OF A NEW SECTION 67-1021C, IDAHO
10 CODE, TO ESTABLISH THE BUSINESS INFORMATION INFRASTRUCTURE FUND; AND
11 DECLARING AN EMERGENCY.

13 Be It Enacted by the Legislature of the State of Idaho:

14 SECTION 1. That Chapter 10, Title 67, Idaho Code, be, and the same is
15 hereby amended by the addition thereto of a NEW SECTION, to be known and des-
16 ignated as Section 67-1021A, Idaho Code, and to read as follows:

17 67-1021A. BUSINESS INFORMATION INFRASTRUCTURE PROJECT. (1) Notwith-
18 standing any laws to the contrary, the state controller shall engage in a
19 project to modernize and replace the state's aging business information in-
20 frastructure, including its financial, payroll, human capital management,
21 budget and procurement systems. The purpose of the project shall be to mod-
22 ernize the state's business information infrastructure and to consolidate
23 duplicative business systems into a centralized enterprise resource plan-
24 ning system in order to achieve standardized business practices and greater
25 transparency in the state's data.

26 (2) The cost of modernizing the state's business information infra-
27 structure shall be equitably distributed among and between all state and
28 public entities that use the services and functions outlined in subsection
29 (1) of this section. On or before June 30 of each year from the effective
30 date of this act until and including June 30, 2022, all moneys deposited to
31 the indirect cost recovery fund resulting from the assessment of the amounts
32 allocated in the annual statewide indirect cost allocation plan pursuant
33 to section 67-3531, Idaho Code, shall be transferred to the business infor-
34 mation infrastructure fund established in section 67-1021C, Idaho Code.
35 Transfers under this section shall occur as requested by the state con-
36 troller and no later than June 30 of each year.

37 SECTION 2. That Chapter 10, Title 67, Idaho Code, be, and the same is
38 hereby amended by the addition thereto of a NEW SECTION, to be known and des-
39 ignated as Section 67-1021B, Idaho Code, and to read as follows:

1 67-1021B. BUSINESS INFORMATION INFRASTRUCTURE GOVERNANCE. (1) A
2 leadership council for the business information infrastructure program con-
3 sisting of the governor, the state controller, the speaker of the house of
4 representatives or his designee and the president pro tempore of the senate
5 or his designee is hereby created. It shall be the duty of the leadership
6 council to garner statewide cooperation in standardizing business practices
7 and gaining efficiencies wherever possible in order to eliminate duplica-
8 tive business systems. The leadership council shall serve as the final
9 authority in resolving any issues that may significantly alter the intended
10 outcomes or completion timeline of the business information infrastructure
11 project. The state controller alone shall be responsible for presenting any
12 such issues to the leadership council.

13 (2) The state controller shall have the authority to create working
14 committees and advisory boards as needed to achieve the goals of the business
15 information infrastructure project.

16 SECTION 3. That Chapter 10, Title 67, Idaho Code, be, and the same is
17 hereby amended by the addition thereto of a NEW SECTION, to be known and des-
18 ignated as Section 67-1021C, Idaho Code, and to read as follows:

19 67-1021C. BUSINESS INFORMATION INFRASTRUCTURE FUND. There is hereby
20 created in the state treasury a fund to be known as the business information
21 infrastructure fund, which shall consist of all moneys credited or trans-
22 ferred in accordance with section 67-1021A, Idaho Code, and any other funds
23 appropriated or transferred in accordance with law. The fund is hereby con-
24 tinuously appropriated to the state controller for the purposes of procure-
25 ment and implementation of a statewide enterprise resource planning system
26 including, but not necessarily limited to, financial, payroll, budget, hu-
27 man capital management and procurement systems. All interest earned on the
28 investment of idle moneys in the fund shall be returned to the fund. All mon-
29 eys in the fund shall be used for the procurement and implementation of the
30 system as set forth in this section. Any unexpended moneys remaining after
31 June 30, 2023, shall revert to the general fund.

32 SECTION 4. An emergency existing therefor, which emergency is hereby
33 declared to exist, this act shall be in full force and effect on and after its
34 passage and approval.
