1 AN ACT  
 2 RELATING TO THE APPROPRIATION TO THE INDUSTRIAL COMMISSION FOR FISCAL YEAR  
 3 2020; APPROPRIATING MONEYS TO THE INDUSTRIAL COMMISSION FOR FISCAL  
 4 YEAR 2020; LIMITING THE NUMBER OF AUTHORIZED FULL-TIME EQUIVALENT  
 5 POSITIONS; AND AMENDING SECTION 72-503, IDAHO CODE, TO INCREASE THE  
 6 SALARIES OF THE INDUSTRIAL COMMISSIONERS.

7 Be It Enacted by the Legislature of the State of Idaho:

8 SECTION 1. There is hereby appropriated to the Industrial Commission  
 9 the following amounts to be expended according to the designated programs  
 10 and expense classes from the listed funds for the period July 1, 2019,  
 11 through June 30, 2020:

15 SECTION 2. FTP AUTHORIZATION. In accordance with Section 67-3519,  
16 Idaho Code, the Industrial Commission is authorized no more than one hun-  
17 dred thirty-two and twenty-five hundredths (132.25) full-time equivalent  
18 positions at any point during the period July 1, 2019, through June 30, 2020,  
19 unless specifically authorized by the Governor. The Joint Finance-Appro-  
20 priations Committee will be notified promptly of any increased positions so  
21 authorized.

22 SECTION 3. That Section 72-503, Idaho Code, be, and the same is hereby  
23 amended to read as follows:

24 72-503. SALARY. Commencing July 1, 201~~8~~9, the annual salary of each  
25 member of the industrial commission shall be one hundred ~~four~~ seven thousand  
26 ~~twenty one hundred forty-one~~ dollars (~~\$104,020~~107,141). Industrial commis-  
27 sioner salaries shall be paid from sources set by the legislature. Each mem-  
28 ber of the industrial commission shall devote full time to the performance of  
29 his duties.
