AN ACT

1 RELATING TO THE APPROPRIATION TO THE DEPARTMENT OF ADMINISTRATION FOR FIS-
2 CAL YEAR 2019; APPROPRIATING ADDITIONAL MONEYS TO THE DEPARTMENT OF
3 ADMINISTRATION FOR THE PUBLIC WORKS PROGRAM FOR FISCAL YEAR 2019; AP-
4 PROPRIATING ADDITIONAL MONEYS TO THE DEPARTMENT OF ADMINISTRATION FOR
5 THE PUBLIC WORKS PROGRAM FOR FISCAL YEAR 2019; APPROPRIATING ADDITIONAL
6 MONEYS TO THE DEPARTMENT OF ADMINISTRATION FOR THE PURCHASING PROGRAM
7 FOR FISCAL YEAR 2019; REDUCING THE APPROPRIATION TO THE DEPARTMENT OF
8 ADMINISTRATION FOR THE PUBLIC WORKS PROGRAM FOR FISCAL YEAR 2019; AU-
9 THORIZING ADDITIONAL FULL-TIME EQUIVALENT POSITIONS; AND DECLARING AN
10 EMERGENCY.

12 Be It Enacted by the Legislature of the State of Idaho:

13 SECTION 1. In addition to the appropriation made in Section 1, Chap-
14 ter 318, Laws of 2018, and any other appropriation provided by law, there is
15 hereby appropriated to the Department of Administration for the Public Works
16 Program \$158,500 from the Administration and Accounting Services Fund to be
17 expended for personnel costs for the period July 1, 2018, through June 30,
18 2019, for the purpose of maintenance personnel at the Chinden Campus.

19 SECTION 2. In addition to the appropriation made in Section 1, Chap-
20 ter 318, Laws of 2018, and any other appropriation provided by law, there is
21 hereby appropriated to the Department of Administration for the Public Works
22 Program \$181,000 from the Permanent Building Fund to be expended for operat-
23 ing expenditures for the period July 1, 2018, through June 30, 2019, for the
24 purpose of project management software annual subscriptions.

25 SECTION 3. In addition to the appropriation made in Section 1, Chap-
26 ter 318, Laws of 2018, and any other appropriation provided by law, there
27 is hereby appropriated to the Department of Administration for the Purchas-
28 ing Program \$87,800 from the Administration and Accounting Services Fund to
29 be expended for operating expenditures for the period July 1, 2018, through
30 June 30, 2019, for the purpose of Central Postal Services increased costs.

31 SECTION 4. Notwithstanding any other provision of law to the contrary,
32 the appropriation made to the Department of Administration for the Public
33 Works Program in Section 1, Chapter 318, Laws of 2018, from the Administra-
34 tion and Accounting Services Fund is hereby reduced by \$158,500 for operat-
35 ing expenditures for the period July 1, 2018, through June 30, 2019, due to
36 maintenance personnel at the Chinden Campus.

37 SECTION 5. FTP AUTHORIZATION. In addition to the authorization pro-
38 vided in Section 2, Chapter 318, Laws of 2018, the full-time equivalent
39 position authorization provided to the Department of Administration is

1 hereby increased by one (1.00) for the period July 1, 2018, through June 30,
2 2019, for the purpose of maintenance personnel at the Chinden Campus.

3 SECTION 6. An emergency existing therefor, which emergency is hereby
4 declared to exist, this act shall be in full force and effect on and after its
5 passage and approval.
