IDAPA 13.01.08 - Rules Governing the Taking of Big Game Animals in the State of Idaho -
Notice of [Amended] [Amended] [Amended] Amended Proclamation (Docket No.
13-0108-1902P).

Pursuant to Section 67-454, Idaho Code, a meeting on the enclosed rules may be called by the
cochairmen or by two (2) or more members of the subcommittee giving oral or written notice to Research
and Legislation no later than fourteen (14) days after receipt of the rules' analysis from Legislative
Services. The final date to call a meeting on the enclosed rules is no later than 06/01/2020. If a meeting is
called, the subcommittee must hold the meeting within forty-two (42) days of receipt of the rules' analysis
from Legislative Services. The final date to hold a meeting on the enclosed rules is 06/29/2020.

The germane joint subcommittee may request a statement of economic impact with respect to a
proposed rule by notifying Research and Legislation. There is no time limit on requesting this statement,
and it may be requested whether or not a meeting on the proposed rule is called or after a meeting has
been held.

Summary and Stated Reasons for the Rule

The Idaho Fish and Game Commission submits notice of amended proclamation regarding IDAPA 13.01.08 - Rules Governing the Taking of Big Game Animals in the State of Idaho. This proclamation has been amended multiple times. The commission notes that it amended its 2019 and 2020 Idaho Big Game Seasons at a March 20 meeting. The commission states that it has established a wait period of five days for eligibility to purchase capped zone elk tags for any person who applies for a controlled elk hunt in 2020.

Negotiated Rulemaking / Fiscal Impact

Not applicable.

Statutory Authority

Section 36-105(3), Idaho Code, provides that the Department of Fish and Game shall be excepted from the requirements of rulemaking when adopting, repealing or amending any proclamations relating to the setting of various seasons and limits, provided it publishes notice of such proposed proclamations in the Idaho Administrative Bulletin and provides notice to Legislative Services for review by the germane joint subcommittees as soon as possible after adoption by the commission.

AUTHORITY: In compliance with Section 36-105(3), Idaho Code, notice is hereby given that at a March 20, 2020 meeting the Commission amended its 2019 and 2020 Idaho Big Game Seasons. The Commission established a wait period of five (5) days for eligibility to purchase capped zone elk tags for any person who applies for a controlled elk hunt in 2020.

Hunter and trappers are advised that they must consult the text of the Commission's official proclamation before hunting and trapping as this notice is merely meant to advise that changes have been made. This notice is not an exhaustive list of those changes.
