AN ACT

1 RELATING TO APPROPRIATIONS; APPROPRIATING ADDITIONAL MONEYS TO THE OFFICE  
2 OF THE STATE CONTROLLER FOR FISCAL YEAR 2021; AUTHORIZING ADDITIONAL  
3 FULL-TIME EQUIVALENT POSITIONS TO THE OFFICE OF THE STATE CONTROLLER  
4 FOR FISCAL YEAR 2021; APPROPRIATING ADDITIONAL MONEYS TO THE OFFICE  
5 OF THE STATE CONTROLLER FOR FISCAL YEAR 2022; AUTHORIZING ADDITIONAL  
6 FULL-TIME EQUIVALENT POSITIONS TO THE OFFICE OF THE STATE CONTROLLER  
7 FOR FISCAL YEAR 2022; APPROPRIATING ADDITIONAL MONEYS TO THE LEGISLA-  
8 TIVE SERVICES OFFICE FOR FISCAL YEAR 2022; AUTHORIZING ADDITIONAL  
9 FULL-TIME EQUIVALENT POSITIONS TO THE LEGISLATIVE SERVICES OFFICE FOR  
10 FISCAL YEAR 2022; AND DECLARING AN EMERGENCY.

12 Be It Enacted by the Legislature of the State of Idaho:

13 SECTION 1. In addition to the appropriation made in Section 1, Chap-  
14 ter 180, Laws of 2020, and any other appropriation provided by law, there is  
15 hereby appropriated to the Office of the State Controller for the Adminis-  
16 tration Program the following amounts to be expended according to the des-  
17 ignated expense classes from the General Fund for the period July 1, 2020,  
18 through June 30, 2021, for the purpose of hiring staff to begin developing an  
19 online financial reporting platform for local governments:

24 SECTION 2. FTP AUTHORIZATION. In addition to the authorization pro-  
25 vided in Section 2, Chapter 180, Laws of 2020, the full-time equivalent posi-  
26 tion authorization provided to the Office of the State Controller is hereby  
27 increased by one (1.00) for the period July 1, 2020, through June 30, 2021.

28 SECTION 3. In addition to any other appropriation provided by law,  
29 there is hereby appropriated to the Office of the State Controller for the  
30 Administration Program the following amounts to be expended according to the  
31 designated expense classes from the General Fund for the period July 1, 2021,  
32 through June 30, 2022, for the purpose of hiring additional staff to develop  
33 and maintain an online financial reporting platform for local governments:

1 SECTION 4. FTP AUTHORIZATION. In addition to any other authorization  
2 provided by law, the full-time equivalent position authorization provided  
3 to the Office of the State Controller is hereby increased by three (3.00) for  
4 the period July 1, 2021, through June 30, 2022.

5 SECTION 5. In addition to any other appropriation provided by law,  
6 there is hereby appropriated to the Legislative Services Office \$92,200 from  
7 the General Fund to be expended for personnel costs for the period July 1,  
8 2021, through June 30, 2022.

9 SECTION 6. FTP AUTHORIZATION. In addition to any other authorization  
10 provided by law, the full-time equivalent position authorization provided  
11 to the Legislative Services Office is hereby increased by one (1.00) for the  
12 period July 1, 2021, through June 30, 2022.

13 SECTION 7. An emergency existing therefor, which emergency is hereby  
14 declared to exist, Sections 1 and 2 of this act shall be in full force and ef-  
15 fect on and after passage and approval.
