SENATE EDUCATION COMMITTEE

CONVENED: **Chairman Thayn** called the meeting of the Senate Education Committee (Committee) to order at 3:08 p.m.

MINUTES APPROVAL: **Senator Woodward** moved to approve the Minutes of February 11, 2021. **Senator Johnson** seconded the motion. The motion carried by **voice vote**.

Senator Den Hartog moved to approve the Minutes of February 15, 2021. **Senator Lent** seconded the motion. The motion carried by **voice vote**.

Senator Cook moved to approve the Minutes of February 16, 2021. **Senator Nelson** seconded the motion. The motion carried by **voice vote**.

PRESENTATION: **Penelope Johnson**, third grade teacher, Davis Connect Online School, gave a presentation to the Committee about the school's successes in the classroom (see Attachment 1). **Ms. Johnson** also walked the Committee members through a lesson plan created for third graders so they could navigate the school's online program.

DISCUSSION: **Senator Johnson** asked Ms. Johnson to identify the optimal class size for this platform. **Ms. Johnson** said 26 students is ideal, but teachers have had 24-30. **Senator Den Hartog** asked what Ms. Johnson's online class prep time is compared to teaching in a traditional classroom. **Ms. Johnson** said prep time is pretty much the same, but she is planning for different lessons while teaching online. **Senator Den Hartog** asked if Davis Connects online program will continue after the pandemic. **Dr. Ryan Hansen**, Director, Digital Learning, Davis School District, said that before the pandemic they had 100 students learning online, or participating in online classes. After the pandemic they had 1,100. Administrators conducted a survey with parents, and expect 1,000 students will continue with online learning. **Senator Lent** asked how Davis Connect ensures instruction aligns with State standards. **Ms. Johnson** said she relies on her school district to make sure Davis Connect is meeting State standards.

Senator Cook asked Ms. Johnson to delineate the experiences gained from online learning. **Ms. Johnson** said student connections and engagement are most important in student success, and she will no longer take that connection for granted. **Senator Cook** said sometimes teachers see issues with students before a parent sees them, and questioned whether they can still see those issues while teaching remotely. **Ms. Johnson** said she is still able to monitor such issues with students, even to the smallest of events such as when a student begins to turn off their camera, and she will check in with them privately to see what might be wrong. **Senator Lent** asked what type of professional development Idaho should explore for expanding online learning. **Dr. Hansen** said the three computer programs that helped with their online learning success were Canvas, Microsoft Teams, and Nearpod. These software programs allow teachers to collaborate and communicate, he said.

ADJOURNED: There being no further business at this time, **Chairman Thayn** adjourned the meeting at 4:14 p.m.
