If you are receiving this message, I have not received documentation that your child has received their meningococcal (MenACWY) immunization, a requirement for starting 12th grade. If the immunization is completed, be sure to fax a copy to the school or email a copy to me. Due to struggles parents may be having getting this immunization completed, the deadline for completion has been extended to September 14. *If you have scheduled an appointment for after this date, contact your physician in order to arrange completion of the vaccination BEFORE September 14.*

According to Idaho Code 39-4801 and Title 2, Chapter 15 Rules and Regulations of the Idaho Department of Health and Welfare, your child will not be able to attend school on September 14th without an updated immunization record on file. This is true whether your student is attending on-campus or remotely. If you have questions about your student's status for school immunization compliance, or would like more details regarding this vaccination, please contact your provider as soon as possible.

There are many local resources where free or low-cost immunizations are available. The [REDACTED] accepts appointments for immunizations. The clinic has opened additional hours to assist families needing immunizations for school entry. Dates of the upcoming immunization clinics:

Wednesday, September 9, 8:00 am – 12:00 pm

Idaho law requires that all 12th graders must have proof of two (2) Meningococcal vaccines in order to attend school. Meningococcal is a two (2) dose series. Proof is required for all students regardless if they are attending in person or online. If you have not provided the school proof, please do so as soon as possible.

Those students who do not show proof of required immunizations by October 16th will be sent home.

The Idaho Immunization Program (IIP) is pleased to partner with high school nursing staff to ensure the implementation of new requirements to Idaho School Immunization Rules.

SCHOOL RULES UPDATE

Idaho School Immunization Rules requires all students (preschool and grades K-12) attending a public, private (including parochial schools), or charter school in Idaho to meet minimum immunization requirements, have a conditional admission form, or a valid exemption on file before attendance in school.

NEW IMMUNIZATION REQUIREMENT FOR 2020-2021 SCHOOL YEAR

The new 12th grade immunization requirement for meningococcal vaccine takes effect for the 2020-2021 school year, and each year thereafter. In addition to the required immunizations for Kindergarten, 1st, and 7th grade, 12th grade students must meet the following minimum immunization requirements prior to admission:

- Students who received their first dose of meningococcal (MenACWY) vaccine before the age of sixteen (16) must have two (2) doses of meningococcal (MenACWY) vaccine.
- Students who received their first dose of meningococcal (MenACWY) vaccine at sixteen (16) years of age and older, or those who have never received a dose, must have one (1) dose of meningococcal (MenACWY) vaccine.

Data for this new requirement will be collected in the annual school immunization report due on November 1, 2020. For more information please see "Annual School Immunization Report" section on our School Immunization Requirements webpage.

Idaho's Immunization Reminder Information System (IRIS) is Idaho's statewide immunization registry that maintains immunization records for children in Idaho. School staff can request an IRIS account to access student immunization records. If you don't have access to IRIS, please request a school user account.

IMMUNIZATION REQUIREMENTS AND COVID-19

We understand this pandemic has presented us with unprecedented and challenging times for our communities. We are committed to supporting our school immunization partners in every way we are able. However, waivers to the new school immunization requirements law are not an option currently.

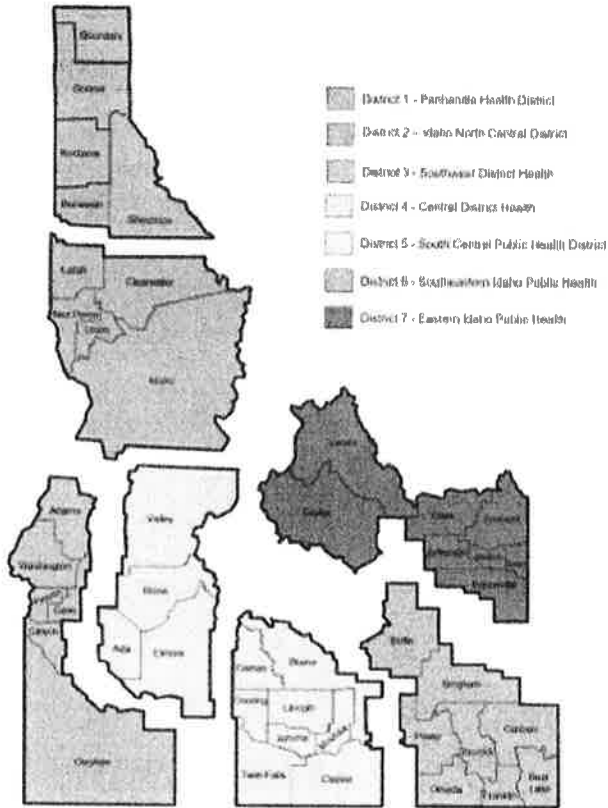
