Legislative Services Office

BLESP

- Sections 33-906, 33-906A, & 33-906B, Idaho Code
- Subsidize a portion of school bond costs
 - 55 of 74 Districts received BLESP
 - FY 2022 = \$20.4 M (Actual)
 - FY 2023 = \$25.4 M (Appropriated)
- Uses a calculated index
 - Market Value (per support unit)
 - Per capita income
 - Unemployment rate



Charter School Facilities Funding

- Section 33-5208(5), Idaho Code
- Used to defray the costs for purchases, fees, loans, and lease costs for real property
- 50% of the per-student amount calculated for school districts from the total statewide issued Bonds & Plant Facility levies
 - \$397.89 per charter student is distributed
 - \$9,641,732 total distribution to 69 charter schools



Facilities Maintenance (2%)

- Section 33-1019, Idaho Code
 - Requires the allocation of funding for facility maintenance for both the schools and the state
- Used for maintenance and repair of school bldgs.
 - Serious & imminent safety hazards on school grounds
- Funding from Lottery Distributions and General Fund
 - PESF Eligible


