HOUSE BILL NO. 826

BY APPROPRIATIONS COMMITTEE

1 AN ACT  
2 RELATING TO THE APPROPRIATION TO THE IDAHO COMMISSION FOR LIBRARIES; AP-  
3 PROPRIATING MONEYS TO THE IDAHO COMMISSION FOR LIBRARIES FOR FISCAL  
4 YEAR 2023; LIMITING THE NUMBER OF AUTHORIZED FULL-TIME EQUIVALENT PO-  
5 SITIONS; PROVIDING REAPPROPRIATION AUTHORITY; REAFFIRMING STATUTORY  
6 COMPLIANCE REGARDING OBSCENE MATERIAL; AND DECLARING AN EMERGENCY AND  
7 PROVIDING AN EFFECTIVE DATE.

8 Be It Enacted by the Legislature of the State of Idaho:

9 SECTION 1. There is hereby appropriated to the Idaho Commission for Li-  
10 braries the following amounts to be expended according to the designated ex-  
11 pense classes from the listed funds for the period July 1, 2022, through June  
12 30, 2023:

27 SECTION 2. FTP AUTHORIZATION. In accordance with Section 67-3519,  
28 Idaho Code, the Idaho Commission for Libraries is authorized no more than  
29 thirty-seven and five-tenths (37.50) full-time equivalent positions at any  
30 point during the period July 1, 2022, through June 30, 2023, unless specifi-  
31 cally authorized by the Governor. The Joint Finance-Appropriations Commit-  
32 tee will be notified promptly of any increased positions so authorized.

33 SECTION 3. REAPPROPRIATION AUTHORITY. There is hereby reappropriated  
34 to the Idaho Commission for Libraries any unexpended and unencumbered bal-  
35 ances appropriated to the Idaho Commission for Libraries from the American  
36 Rescue Plan Fund for fiscal year 2022, in an amount not to exceed \$2,300,000,  
37 to be used for nonrecurring expenditures for the period July 1, 2022, through

1 June 30, 2023. The Office of the State Controller shall confirm the reappro-  
2 priation amount, by fund, expense class, and program, with the Legislative  
3 Services Office prior to processing the reappropriation authorized herein.

4 SECTION 4. OBSCENE MATERIAL. The Idaho Commission for Libraries shall,  
5 to the maximum extent possible with available staffing and resources: (1)  
6 Verify that the Commission's library resources for K-12 students comply with  
7 Sections 33-137 and 33-2508, Idaho Code; (2) Incorporate references to rele-  
8 vant statutes regarding obscene material in the Commission's Electronic Re-  
9 sources Collection Development Policy; and (3) Provide a written report to  
10 the Joint Finance-Appropriations Committee no later than September 1, 2022,  
11 detailing progress in complying with this section and any associated inter-  
12 nal audits.

13 SECTION 5. An emergency existing therefor, which emergency is hereby  
14 declared to exist, this act shall be in full force and effect on and after  
15 July 1, 2022.
