**Mr. Nate Osborne**, Analyst, LSO Budget & Policy Analysis, presented the FY 2023 budget for the Commission for the Blind and Visually Impaired.

**Mr. Osborne** presented the FY 2023 budget for the Division of Veterans Services. He explained the agency's duties include operating the State's veterans homes, managing the State's veterans cemeteries, and providing medical and assisted living care to veterans.

Riggs**, for the Division of Veterans Services, for FY 2023, to approve 447.50 FTP, \$1,531,800 from the General Fund, \$24,655,000 from dedicated funds, and \$26,632,200 from federal funds, for a grand total of \$52,819,000, which includes personnel benefit costs, replacement costs, change in employment compensation, and line items.

**Ms. Janet Jessup**, Senior Analyst, LSO Budget & Policy, presented the FY 2022 supplemental requests from the Office of the State Board of Education.

Cook**, for FY 2022, for the Office of the State Board of Education, an additional 1.00 FTP, \$50,000,000 onetime from the American Rescue Plan State Fiscal Recovery Fund, and \$1,035,000 onetime from the General Fund, to provide grants that directly support learning for students and parents.

**SUBSTITUTE MOTION:** **Sen. Crabtree** made a substitute motion, seconded by **Rep. Nash**, for FY 2022, for the Office of the State Board of Education, an additional 1.00 FTP and \$25,000,000 onetime from the American Rescue Plan State Fiscal Recovery Fund to provide grants that directly support learning for students and parents.

**Sen. Crabtree** stated his motion protected the General Fund.

**Rep. Horman** stated her motion reflected the fiscal note of **S 1255**, which states General Funds are requested for the program. She expressed concern that children and families would bear the costs of administering the program. **Rep. Horman** stated her motion appropriates the monies for FY 2022 to save the administrative burden on the State Board, per the Governor's recommendation. She further explained her motion would allow eligibility for an additional 1,185 children.

In response to a committee question, **Rep. Horman** explained while her motion asked for ongoing FTP and ongoing funds, should the Legislature not approve this program in the future, the FTP and funds would be removed from the budget.

**Sen. Woodward** stated the Strong Families, Strong Students II program would be instituted on the same timeline whether appropriated as a FY 2022 supplemental or a FY 2023 line item. He questioned whether there was a difference in administrative burden between the two motions and expressed his preference to reappropriate monies for the program as its funds deplete.

Nash**, for the State Board of Education, for FY 2023, to approve 63.25 FTP, \$9,309,100 from the General Fund, \$7,078,300 from dedicated funds, and \$42,500,500 from federal funds, for a grand total of \$58,887,900, which includes personnel benefit costs, replacement costs, change in employment compensation, and line items.

**Sen. Crabtree** explained the percentage increase from the FY 2022 budget was due to shifting personnel costs from universities' budgets to this budget; without those personnel shifts, the FY 2023 budget would show a 2.9% increase over the FY 2022 budget.

The Office of the State Controller shall confirm the reappropriation amount, by fund, expense class, and program, with the Legislative Services Office prior to processing the reappropriation authorized herein.

The State Controller shall confirm the reappropriation amount, by fund, expense class, and program, with the Legislative Services Office prior to processing the reappropriation authorized herein.

**Ms. Christine Otto**, Senior Analyst, LSO Budget & Policy Analysis, presented the FY 2023 budget for the Public Employee Retirement System of Idaho (PERSI).

**MOTION:**

**Sen. Grow** made a motion, seconded by **Rep. Syme**, for PERSI, for FY 2023, to approve 73.0 FTP and \$12,494,000 from dedicated funds, for a grand total of \$12,494,000, which includes personnel benefit costs, replacement costs, change in employment compensation, and line items.

**Sen. Grow** referenced the line item for increased personnel costs for an actuary. He explained last year the agency spent \$335K for actuarial contracted work because it could not hire an actuary at the budgeted base salary. This line item salary increase intends to provide costs savings to the agency.

Amounts necessary to pay all other investment expenses related to the Portfolio Investment Program are perpetually appropriated to the Public Employee System Board as provided in Section 59-1311(4)(a), (b) and (c), Idaho Code.

**Ms. Otto** presented the FY 2023 budget for the Division of Human Resources.

Syme**, for the Division of Human Resources, for FY 2023, to approve 22.0 FTP and \$1,250,000 from the General Fund, and \$3,421,300 from dedicated funds, for a grand total of \$4,671,300, which includes personnel benefit costs, replacement costs, change in employment compensation, and line items.

**Sen. Cook** stated this motion largely reflected the Governor's recommendation with the exception of the Compensation and Classification Study, which was recommended as a supplemental for FY 2022 but moved to a FY 2023 line item.

SECTION \_\_. EMPLOYEE COMPENSATION. In accordance with Chapter 53, Title 67, Idaho Code, the Division of Human Resources shall shift the salary structure upward by three percent (3%) beginning on July 1, 2022, with the exception of the minimum wage of \$7.25 per hour at pay grade D to provide a 3% salary increase to all permanent positions. The division shall also maintain the job classifications currently on payline exception. Each agency is appropriated \$1.25 per hour for permanent employees to be distributed based on merit with the flexibility for agency heads and institution presidents to distribute funds for recruitment and retention purposes in hard to fill, hard to retain positions.
