**CONVENED:** **Co-Chairman Agenbroad** called the meeting of the Joint Finance-Appropriations Committee (Committee) to order at 1:36 p.m.

**PRESENTATION:** **HONORING OF THE COMMITTEE PAGES SHAYANNE RICHARDSON AND SAMUEL WAKEFIELD; Co-Chairmen Agenbroad and Youngblood**  
The Chairmen thanked the Pages for their service to the Committee, presented them with a letter and gift, and had them describe what they have learned during their time in service to the Legislature.

**LSO STAFF  
PRESENTATION:** **DEPARTMENT OF COMMERCE FISCAL YEAR (FY) 2023 APPROPRIATION - RECONSIDERATION OF DEFEATED APPROPRIATION - JFAC RULE 14; Matt Farina, Legislative Services Office (LSO) Budget and Policy Analyst**  
**Mr. Farina** explained the changes from the previous motion were reducing the amount appropriated from the American Rescue Plan Act of 2021 (ARPA) to zero and removing four Full-Time Equivalent Positions (FTP) associated therewith. He discussed line seven of the budget is now a \$2 million cash transfer into the Idaho Opportunity Fund from the General Fund for FY 2023. **Mr. Farina** informed of the change from the Infrastructure Investments and Jobs Act, where previously there was \$100 million request and now has been reduced to \$50 million.

Also included are the following line items: line item 1, which provides 1.00 FTP and \$78,900 for tourism staff; line item 2, which provides \$5,536,000 for tourism promotion; line item 3, which provides \$4,975,000 for community development grants; line item 4, which provides \$171,300 for operating expenditures; line item 5, which provides \$1,000,000 for economic planning; line item 7, which provides a \$2,000,000 cash transfer from the General Fund to the Idaho Opportunity Fund; line item 47, which provides \$50,000,000 for broadband infrastructure; and line item 51, which provides \$1,000,000 for the Idaho Food Bank. The totals for this motion for FY 2023 are 44.00 FTP, \$6,408,300 from the General Fund, \$25,949,700 from dedicated funds, and \$68,285,000 from federal funds for a grand total of \$100,643,000; seconded by **Representative Youngblood**.

**INTENT LANGUAGE:**

SECTION \_\_. REAPPROPRIATION AUTHORITY. There is hereby reappropriated to the Department of Commerce any unexpended and unencumbered balances appropriated or reappropriated to the Department of Commerce from the Idaho Broadband Fund for fiscal year 2022, not to exceed \$35,000,000, to be used for nonrecurring expenditures for the period July 1, 2022, through June 30, 2023. The Office of the State Controller shall confirm the reappropriation amount, by fund, expense class, and program, with the Legislative Services Office prior to processing the reappropriation authorized herein.

SECTION \_\_. BROADBAND INFRASTRUCTURE. Notwithstanding any law to the contrary, the agency shall allocate all moneys appropriated to it from the Infrastructure Investment and Jobs Act for the purpose of broadband grants at the direction of the Idaho Broadband Advisory Board.

SECTION \_\_. CASH TRANSFER. There is hereby appropriated and the Office of the State Controller shall transfer \$2,000,000 from the General Fund to the Idaho Opportunity Fund on July 1, 2022 or as soon as practicable thereafter.

**COMMISSION FOR LIBRARIES FY 2023 APPROPRIATION -  
RECONSIDERATION; Matt Farina, Legislative Services Office (LSO)  
Budget and Policy Analyst**

**Mr. Farina** explained this budget has one change from the budget previously passed by the Committee, being line item one is now zero. It previously had \$307,000 from the General Fund. The remaining line items are the same as the previous budget.

**DISCUSSION:**

The Committee and Mr. Farina discussed the change made to the budget. In response to Committee questions, **Stephanie Bailey-White**, Idaho State Librarian and Director of the Idaho Commission for Libraries, stated the electronic book collection will be put into maintenance mode, and they are planning an internal audit of their collection as well as reviewing their policies, oversight, and procedures from a school library perspective rather than a public library perspective.

SECTION \_\_. IDAHO DIGITAL E-BOOK ALLIANCE. The Idaho Commission for Libraries shall, to the maximum extent possible with available staffing and resources: 1) Verify that digital and online library resources for K- 12 students comply with Section 33-2508, Idaho Code; 2) Incorporate references to relevant statutes regarding obscene material in the Commission's Electronic Resources Collection Development Policy; and 3) Provide a written report to the Joint Finance-Appropriations Committee no later than September 1, 2022, detailing progress in complying with this section and any associated internal audits.

SECTION \_\_. TECHNOLOGY PROJECTS. Moneys appropriated in Section 1 from the Capital Projects Fund, shall be expended for technology projects that comply with Section 33-2741, Idaho Code, and the federal Children's Internet Protection Act. Presumptively eligible projects include network infrastructure and access points that are able to provide advanced threat protection and high-quality content filtering. Nothing in this section shall prevent expansion to existing library facilities in connection with technology projects.

**Senator Nye** read Idaho Code § 33–2508; DIGITAL AND ONLINE LIBRARY RESOURCES FOR K-12 STUDENTS. If the commission for libraries provides digital or online library resources for the use of students in kindergarten through grade 12, the commission shall comply with all provisions of section 33-137, Idaho Code.

In response to Committee questions, **Stephanie Bailey-White**, Idaho State Librarian and Director of the Idaho Commission for Libraries, explained each school library has their own collection development policy that includes a reconsideration portion allowing libraries to purchase materials and to also reconsider those materials if problems arise. She stated those policies are put in place by locally elected officials, either school board members or library trustees, who have oversight for each public and school library in the state. **Ms. Bailey-White** discussed that the Commission for Libraries does not have physical books that can be checked out, they have the digital talking book library service for people who cannot read standard print, and electronic book databases.

**Ms. Lippitt** explained a trailer appropriation was needed to fund **H 747**, which sets the salaries of the state constitutional officers for the next four years starting on the first Monday in January 2023. An appropriation of \$45,200 funds the increase for January through June 2023, including the cost of variable benefits. An annualization for the same amount will be needed for FY 2024, for July through December 2023. **H 747** provided a 9.5 percent salary increase for the Governor, Lieutenant Governor, Secretary of State, State Treasurer, State Superintendent, State Controller, and Attorney General.

The total estimated cost is \$600,000 from the General Fund.

**Mr. Bybee** explained that **S 1380** creates a rural veterinarian loan repayment program under Title 25, Chapter 41 Idaho Code. The fund for this program would pay for education related costs or debts for qualified veterinarians providing care for agricultural production animals in rural areas. He stated eligible applicants would received up to \$25,000 per year for up to three years with a commitment to work for four years. The fiscal note asks for an appropriation of \$250,000 annually for up to ten applicants.

The increase to dedicated revenue to the expendable Big Game Depredation Fund by \$250,000 annually.
