SENATE BILL NO. 1208

AN ACT

1 RELATING TO THE APPROPRIATION TO THE PUBLIC SCHOOLS EDUCATIONAL SUPPORT
2 PROGRAM'S DIVISION OF FACILITIES; APPROPRIATING MONEYS TO THE PUB-
3 LIC SCHOOLS EDUCATIONAL SUPPORT PROGRAM'S DIVISION OF FACILITIES FOR
4 FISCAL YEAR 2024; PROVIDING THE NECESSARY FUNDS FOR THE BOND LEVY EQUAL-
5 IZATION PROGRAM; TRANSFERRING MONEYS TO THE PUBLIC SCHOOL INCOME FUND
6 FOR FISCAL YEAR 2024; AND DECLARING AN EMERGENCY AND PROVIDING AN EFFEC-
7 TIVE DATE.

9 Be It Enacted by the Legislature of the State of Idaho:

10 SECTION 1. There is hereby appropriated to the Public Schools Educa-
11 tional Support Program's Division of Facilities the following amounts to be
12 expended from the listed funds for the period July 1, 2023, through June 30,
13 2024:

19 SECTION 2. TRANSFER. Of the moneys appropriated to the Public Schools
20 Educational Support Program's Division of Facilities, the amount necessary
21 to fund the provisions of Section 33-906, Idaho Code, is hereby transferred
22 and appropriated to the Bond Levy Equalization Fund. If the funding appro-
23 priated in Section 1 of this act is insufficient to meet the requirements of
24 Section 33-906, Idaho Code, the difference shall be withdrawn and paid from
25 the Public Education Stabilization Fund, notwithstanding any other provi-
26 sion of law to the contrary.

27 SECTION 3. TRANSFER FOR PUBLIC SCHOOLS EDUCATIONAL SUPPORT PROGRAM. Of
28 the moneys appropriated in Section 1 of this act, there is hereby appropri-
29 ated and the Office of the State Controller shall transfer \$14,479,200 from
30 the General Fund to the Public School Income Fund to be expended for the Pub-
31 lic Schools Educational Support Program's Division of Facilities for the pe-
32 riod July 1, 2023, through June 30, 2024.

33 SECTION 4. An emergency existing therefor, which emergency is hereby
34 declared to exist, this act shall be in full force and effect on and after
35 July 1, 2023.
