The Chairmen introduced the second half session Pages to the Committee and had them introduce themselves and discuss why they chose to become a Page.

LSO STAFF PRESENTATION:

STATE APPELLATE PUBLIC DEFENDER (SAPD) - OFFICE OF INFORMATION TECHNOLOGY SYSTEMS (OITS) INCREASED STORAGE CAPACITY - FISCAL YEAR (FY) 2023 SUPPLEMENTAL; Tim Hibbard, Analyst, Legislative Services Office (LSO) Budget and Policy Analysis

**Mr. Hibbard** stated the SAPD was requesting a FY 2023 supplemental appropriation for \$67,500 one time from the General Fund for operating expenditures to increase electronic record storage capacity for four new capital cases. He provided details regarding the cases and current capacity for electronic filings; and that it was a supplemental request due to trials occurring

in the current FY, April 2023.

**DISCUSSION:** In response to Committee questions, **Mr. Hibbard** reviewed the \$67,500 quote

from the vendor GCSIT for a hard drive large enough to store the anticipated volume of electronic media. **Eric Fredericksen**, Director, SAPD, reminded the Committee that if the equipment costs less than the quoted amount, SAPD

will return funds to the state.

**Mr. Hibbard** explained this agency's one time supplemental request would be used to pay for two capital conflict attorneys, a mitigation expert, an investigator, and expert witness funds for the costs associated with new capital

cases, and other capital case and evidentiary hearing costs.

**Mr. Hibbard** instructed that the Office of the Attorney General requested an additional \$300,000 from the General Fund to pay for the salary increases of new Deputy Attorney General positions, and a pay increase given to two employees as a result of the Fair Labor Standards Act audit.

Ms. Lippitt explained the agency requested \$28,000 in ongoing personnel costs, and \$2,700 one time, for an employee benefits specialist. The ongoing personnel costs address the 30 percent increase in workload following the 26 school districts joining the Idaho employee medical and dental plan last fall. The one time monies will provide for a laptop, two monitors, and office furniture.
