Members of the Senate State Affairs Committee –

In light of tomorrow's hearing on HB 155, I write to you today to ask for your consideration in amending HB 155 to provide some clarity on exemptions provided to state employees vs. employees of political subdivisions. I have spoken with the bill sponsor, Rep. Monks, who is amendable to your consideration of our request.

As HB 155 is currently drafted, page 1, I.C. 67-2359(1)(c) states: "Be hired by the state or maintain employment with the state. An employee of the state or a political subdivision of the state may not be discriminated against on the basis of such employee's coronavirus immunization status, including decisions relating to promotion, compensation, or job duties. However, the state may require..." The bill then goes on to provide three exemptions for testing and vaccine requirements related to employment and job duties that I read as only applying to state employees. However, the section above implicates employees of political subdivisions and the city does have fire and building code inspectors that do go out to private businesses who might need to comply with that business' own health requirements as part of their employment with the city.

My ask to the committee is to amend the language so that it includes political subdivisions as well in those exemptions. I think a simple amendment could read: line 28 – "However, the state or a political subdivision of the state may require:" and then continue with the exemption list.

I plan to be at the hearing tomorrow and would be happy to speak to our request as well.

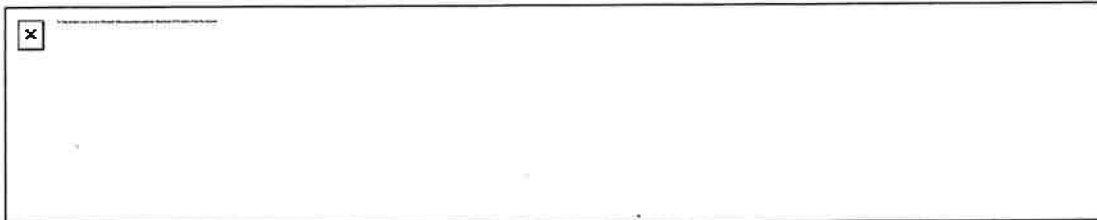

On the evening of February 25, Woody Harrelson was the guest host of *Saturday Night Live*. Assuming the tone and posture of a jester such as Will Sommers in the court of Henry VIII—that is, playing the fool while speaking frankly to potentially dangerous people—the comedian and actor told his audience the truth. He began by saying that in the year 2019, he was presented with a movie pitch that was “the craziest I’ve ever heard.”

This morning a friend sent me a report on Mr. Harrelson's monologue and a summary of mainstream media reporting on it, which characterized his remarks as "**anti-vaccine conspiracy theory.**" As the German philosopher, Arthur Schopenhauer, noted:

All truth passes through **three stages**. First, it is ridiculed. Second, it is violently opposed. Third, it is accepted as being self-evident.

Judging by commentary in *Variety*, the *Washington Post*, *Rolling Stone*, *USA Today*, *Vanity Fair*, *Hollywood Reporter*, the *Daily Beast*, *Page Six*, *Yahoo Entertainment*, *TMZ*, *Forbes*, and *People*, many American journalists are still stuck in **the first brainwashed stage** in their response to this truth. Though their particular egos may never allow them to accept this truth as self-evident, most of humanity eventually will.

A notable apostate from the current orthodoxy was Elon Musk, who tweeted of the media response:

Maybe they don't realize that their propaganda is wrong.

It's notable that much of the commentary characterizes Harrelson's monologue as "anti-vaccine" or "anti-vax," even though he used the word "drugs" and not "vaccine." This suggests that his critics are fully aware of the scheme that was imposed on us—lock everyone down, offer the vaccine as the sole and necessary way back to safety and normalcy, insist and even mandate that we all get it.

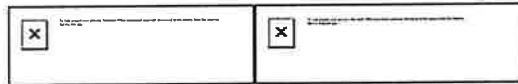
If only we could somehow persuade all of these benighted journalists to read it.
