
Disposables, Generally Illicit, are Largest User Segment by Far

Louisiana Data Shows E-Vapor Directories Address Illicit Market and Support Harm Reduction

Several states have implemented e-vapor directories to curb the proliferation of illicit e-vapor products. Data from Louisiana, one of the first states to implement a comprehensive directory, shows that these directories


work. They address the illicit e-vapor marketplace while maintaining regulated smokefree options for adult consumers.

Importantly, e-vapor directories encourage voluntary compliance by creating a transparent regulatory system where it is easy to remain compliant.



Directories Encourage Consumers to Return to Compliant Products

Louisiana's e-vapor directory law took effect in the Fall of 2023.¹ According to sales data, businesses and consumers reacted by going to the regulated market for e-vapor products. In the weeks following publication of the directory, illicit products completely disappeared from the tracked traditional channels (see chart below).

From January to March of 2024, enforcement of the directory was temporarily paused due to litigation over Louisiana's single subject laws.² As is evident on the chart, in that period (see blue box), illicit products reemerged on retail shelves. Illicit products disappeared immediately following re-implementation.


Of course, some illicit trade may continue outside these channels, but this data positively indicates that directories are driving adult consumers back to the regulated market by offering a transparent marketplace that can satisfy adult demand.

Louisiana E-Vapor Directory Did Not Increase Cigarette Consumption

Some opponents of this type of regulation claim that e-vapor directories are designed to drive consumers back to cigarettes, but the reality is quite different.

The implementation of the directory did not have any impact on the decline in sale of cigarettes.

As visualized on the chart below, sales of cigarettes in Louisiana (blue line, right axis) follow the national trend (orange line, left axis) before and after publication of the directory.
