Gender Equity Center

FY25 Assessment and Restructuring Plan:

The Gender Equity and Student Equity Centers will close in late Fall 2024. A new Student Connections and Success Center will open in their place. The focus of the Student Connections and Success Center will be to support, retain and graduate students that experience achievement and retention gaps, especially students identified in Boise State's Strategic Enrollment and Retention Plan (SERP) (e.g., first-generation, Pell-grant eligible, rural, Hispanic/Latinx, and male students). Services for all students will include support for mental health, physical safety, food and financial security, and career preparedness.



Below is the information requested by Idaho State University (ISU) on the Diversity Resource Center (DRC) and Gender Resource Center (GRC). ISU is currently working to close both centers and will be shifting programming to focus on academic success for all students through a new center, the Bengal Student Success Center. The Bengal Student Success Center will serve as a connecting point for students seeking academic support through services like tutoring and advising. Current FTP will be reallocated to Student Affairs to support ongoing all student engagement efforts. Any events previously coordinated by the DRC and GRC will be shifted to student clubs should the students decide to continue hosting them.

These changes will take effect by December 2024.

Diversity Resource Center

ISU's Diversity Resource Center (DRC), established in 2004, is a place where students, staff, and community members can come together to support students and the Bengal community. Everyone is welcome to participate in the DRC's small group activities, which include pumpkin painting, crochet, book discussions, and a Veterans' Day luncheon.

The DRC is staffed by a .9 FTE staff member, with limited student worker and work-study support. The DRC is funded through local gifts and other resources and receives no state-appropriated funds.

ISU's Janet C. Anderson Gender Resource Center (GRC) was founded by the ISU Student Senate in 1998 to honor and recognize the retiring Dean of Student Affairs, Janet C. Anderson.

The GRC offers programs to the campus community on topics ranging from domestic violence prevention, human trafficking prevention, bystander intervention, and healthy relationships.

The GRC is staffed by a .9 FTE staff member, with limited student worker and work-study support. The GRC is funded through local gifts and other resources and receives no state-appropriated funds.

SUBJECT: Legislative Inquiry – Diversity, Equity, and Inclusion

In response to your inquiry regarding SB1176 (2023), which mandates that no state-appropriated funds are used to support diversity, equity, inclusion, or social justice ideology as part of any student activities, clubs, events, or organizations on campus, Lewis-Clark State College (LC State) verifies that no state-appropriated funds are being used to support diversity, equity, inclusion, or social justice ideology in such activities.

Furthermore, in compliance with House Bill 387 from the 2021 legislative session, LC State has identified a portion of its non-appropriated student government activity fee as supporting student activities, clubs, and organizations. This portion of the student government fee has been made optional for students and is currently set at \$3.00 per semester.

In response to your request for departmental data and clarification on programs for Fiscal Year 2024 (FY24), we are providing the following detailed financial and programmatic information for two programs. While this data is not directly related to diversity, equity, or inclusion initiatives, it may be relevant to your inquiry.

Native American, Minority, and Veterans' Services:

LC State's Native American, Minority, and Veterans' Services Department provides critical support to Native American, minority, and veteran students. The department offers academic advising, retention services, cultural programming, and leadership opportunities to help students succeed both academically and personally.
