# Summary and Stated Reasons for the Rule

The Division of Occupational and Professional Licenses submits notice of proposed rulemaking at IDAPA 24.29.01 - Rules of Procedure of the Idaho Certified Shorthand Reporters Board (ZBR Chapter Rewrite). According to the Division, they are rewriting the rules for shorthand reporters as part of the Governor's Zero-Based Regulation executive order, and the proposed rule is intended to streamline and simplify the rule language. The most prominent change to the rules for shorthand reporters is the elimination of an examination requirement for applicants.

# **Negotiated Rulemaking / Fiscal Impact**

Negotiated rulemaking was conducted, and notice was published in the April edition of the Idaho Administrative Bulletin. There is no anticipated fiscal impact associated with this rulemaking.

# **Statutory Authority**
