STATEMENT OF PURPOSE

This appropriation to the Special Programs under the State Board of Education provides enhancements to the FY 2025 maintenance budget that includes additional staffing, additional operating expenditures, funding for the rural educator incentive program, and the additional 2% CEC.

FISCAL NOTE

This appropriation provides an additional \$936,400 to the maintenance appropriation provided to the Special Programs which are organized within the State Board of Education and found in House Bill 458. Table 1 shows incremental adjustments to the budget found in the bill, of which the ongoing increase is \$936,400, and there are no one-time appropriations. Table 2 shows all the adjustments leading to the FY 2025 Total. The total budget for Special Programs is \$35,831,400.
