STATEMENT OF PURPOSE

This appropriation to the Commission for the Blind and Visually Impaired provides enhancements to the FY 2025 maintenance budget that includes additional appropriation for software procurement, and the additional 2% CEC.

FISCAL NOTE

This appropriation provides an additional \$1,203,100 to the maintenance appropriation provided to the Commission for the Blind and Visually Impaired found in House Bill 459. Table 1 shows incremental adjustments to the budget found in the bill, of which the ongoing increase is \$123,200 and the onetime increase is \$1,079,900. Table 2 shows all the adjustments leading to the FY 2025 Total. The total budget for the Commission for the Blind and Visually Impaired is \$7,092,100.
