LIMITING THE NUMBER OF AUTHORIZED FULL-TIME EQUIVALENT POSITIONS; PRO VIDING FOR ACCOUNTABILITY REPORTS; AND DECLARING AN EMERGENCY AND PRO VIDING AN EFFECTIVE DATE.

7 Be It Enacted by the Legislature of the State of Idaho:

8 SECTION 1. There is hereby appropriated to the Public Utilities Com-9 mission the following amounts to be expended according to the designated ex-10 pense classes from the listed funds for the period July 1, 2024, through June 11 30, 2025:

SECTION 2. FTP AUTHORIZATION. In accordance with Section 67-3519, Idaho Code, the Public Utilities Commission is authorized no more than forty-eight (48.00) full-time equivalent positions at any point during the period July 1, 2024, through June 30, 2025, unless specifically authorized by the Governor. The Joint Finance-Appropriations Committee will be notified promptly of any increased positions so authorized.

29 SECTION 3. ACCOUNTABILITY REPORTS. Funds specifically identified in statute or in an appropriation act as intended for a certain purpose may 30 be used only for that purpose. Funds provided in this act are subject to 31 accountability reports and management reviews in accordance with Section 32 33 67-702, Idaho Code, provided the Legislative Services Office auditor has sufficient resources to conduct those reports. State agencies that are 34 authorized to contract for outside audits shall submit those reports to the 35 Joint Finance-Appropriations Committee when those reports become avail-36 able. 37

SECTION 4. An emergency existing therefor, which emergency is hereby declared to exist, this act shall be in full force and effect on and after July 1, 2024.
