## STATEMENT OF PURPOSE

#### RS31491 / S1385

This appropriation to the Idaho Commission for Libraries provides enhancements to the FY 2025 budget that include funding for summer STEM programs, the continuation of the digital access for all Idahoans grant, the additional 2% CEC, and reappropriation authority.

### FISCAL NOTE

This appropriation provides an additional \$842,500 to the maintenance appropriation provided to Economic Development agencies found in Senate Bill 1270. The table below shows incremental adjustments to the budget for FY 2025, of which the ongoing increase is \$92,500 and \$750,000 is appropriated onetime. The total budget for the Idaho Commission for Libraries is \$7,459,000.
