## SENATE BILL NO. 1402

## BY FINANCE COMMITTEE

AN ACT

RELATING TO THE APPROPRIATION TO THE DIVISION OF VETERANS SERVICES; APPROPRIATING ADDITIONAL MONEYS TO THE DIVISION OF VETERANS SERVICES FOR FISCAL YEAR 2025; PROVIDING REAPPROPRIATION AUTHORITY FOR THE FEDERAL GRANT FUND; AND DECLARING AN EMERGENCY AND PROVIDING AN EFFECTIVE DATE.

Be It Enacted by the Legislature of the State of Idaho:

SECTION 1. In addition to any other appropriation provided by law, there is hereby appropriated to the Division of Veterans Services the following amounts to be expended according to the designated expense classes from the listed funds for the period July 1, 2024, through June 30, 2025:

SECTION 2. REAPPROPRIATION AUTHORITY. There is hereby reappropriated to the Division of Veterans Services any unexpended and unencumbered balances appropriated or reappropriated to the division from the Federal Grant Fund for fiscal year 2024, to be used for nonrecurring expenditures for the Boise Veterans Home and the Boise Cemetery for the period July 1, 2024, through June 30, 2025. The Office of the State Controller shall confirm the reappropriation amounts, by fund and expense class, with the Legislative Services Office prior to processing the reappropriation authorized herein.

SECTION 3. An emergency existing therefor, which emergency is hereby declared to exist, this act shall be in full force and effect on and after July  $1,\ 2024$ .
